**Burial Ground Maintenance Grant 2024**  
**Eligibility & Conditions**

1. Galway County Council's Public Liability Insurance will operate to cover the liability of Community Groups involved in the clean-up / maintenance of burial grounds subject to the following conditions:
  - Cover will not operate for demolition of walls, buildings, structures, tree felling, lopping of branches, use of chainsaws.
  - Cover will not extend to any person under the age of 16 years.
  - Appropriate safety measures must be taken to safeguard participants in the use of equipment / tools / ladders, etc.
  - If the community group have in place any other public liability policy, any claim arising from an accident shall be against that policy.
2. A Grant of €200, €300, €450, €600, €900 OR €1,400 shall be made available to successful applicants in respect of each Burial Ground. The Grant amount will be determined by the level of maintenance carried out.
3. Guidelines for the Conservation and Care of Graveyards must be adhered to.
4. The Grant must be used for the purpose of purchasing trees, shrubs, brushes, shovels, grass cutting and other incidental items which are required to carry out maintenance works to the Burial Ground.
5. The following works are prohibited:
  - Cutting of hedgerow vegetation between March 1st & August 31st (Wildlife (Amendment) Act, 2000)
  - Disturbance or cleaning of gravestones or grave kerbs.
  - Removal of ivy from old church structures or ruins
  - Laying of new pathways

**Who are we and why do we require your information?**

The vision for Galway County by Galway County Council is a county with a clear sense of identity, reflecting on its heritage, language and culture that promotes sustainable economic and community development, citizen and stakeholder engagement, develops essential infrastructure and protects our environment.

The objective of the Environment Section is to protect, improve, promote and enhance our Environment in the interests of the quality of life, culture and heritage for present and future generations. The processing of the personal data will be carried out for the purpose of paying the maintenance grant if awarded.

**What are our lawful bases for processing your Personal Data?**

Galway County Council's lawful basis for processing the Personal Data collected under the Burial Ground Maintenance Grant is as follows:

- Processing is necessary for the performance of task carried out in the public interest or in the exercise of official authority vested in Galway County Council in accordance with Article 6 1 (e) of the General Data Protection Regulation, 2016
- Public Health (Ireland) Act 1878, Rules and Regulations for the Regulation of Burial Grounds 1888, as amended (See Appendix I).

**Who will your Personal Data be shared with?**

We may share your personal data internally with relevant departments for the purpose of fulfilling the above-stated legal basis. We will share with the Finance Department for the processing of the payment, and we may have to share with Internal Audit or the Government Auditor if we are subject to an audit.

Galway County Council will take steps to ensure any disclosures of personal data are necessary and proportionate, as required by law. Whenever we share your personal information, sharing options will be evaluated to ensure that your data is shared in the most secure manner.

A letter will be issued stating the amount of grant awarded.
