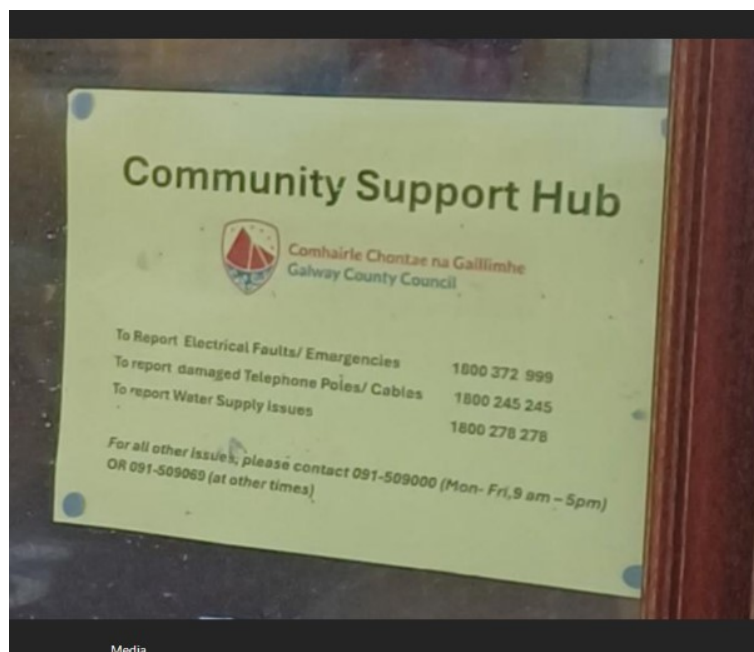

COMMUNITY RESPONSE - STORM ÉOWYN

The Community Department coordinated the Community Response elements of the local authority supports to people who were significantly affected by Storm Éowyn. In the first instance, this took the form of reaching out to local community groups & clubs and developing a network of Emergency Response Hubs across the County to assist with basic needs such as hot drinks, kitchen facilities, phone charging, broadband, and access to shower facilities. As the worst



affected County regarding power outages, Galway County had the highest number of hubs in the country with 54 at the height of outages, reducing to 36 hubs as power was reconnected to the majority of households. The Council is deeply appreciative of, and indebted to, the numerous volunteers and facilities who responded so quickly and efficiently to the needs of their local areas. A Community Response Forum was also established including ESB, An Post, An Garda Síochána, HSE, Local Development Companies, etc., to focus on the welfare of vulnerable or elderly people across the various agencies and coordinate targeted supports to these individuals. These supports included phone and in-person checks on vulnerable people, provision of medical supports, and linkages with meals and accommodation where required. The emergency helpline was utilised while e-mail facilities were also established to respond to individual queries about supports and services, with information made available through websites, social media, and local media.

RURAL GRANTS SCHEME

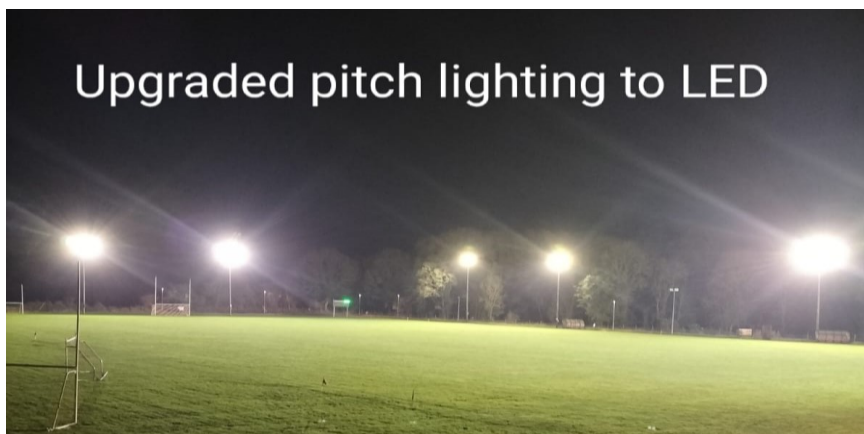
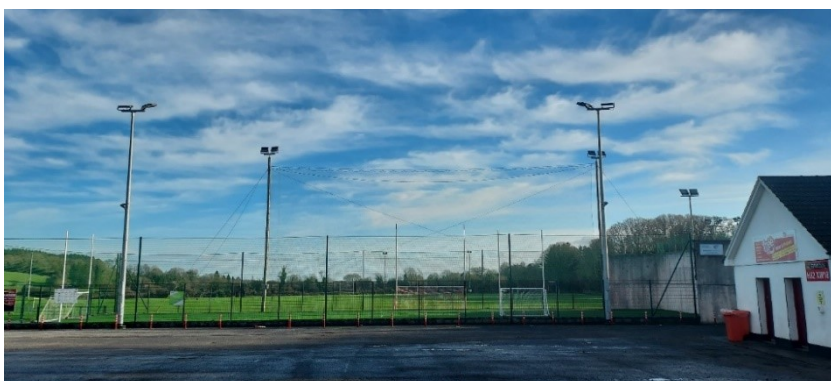
The CLÁR 2023 programme, which aims to support rural areas experiencing population decline, has successfully completed several projects towards the end of 2024. These projects include the development of community facilities, sports amenities. The following

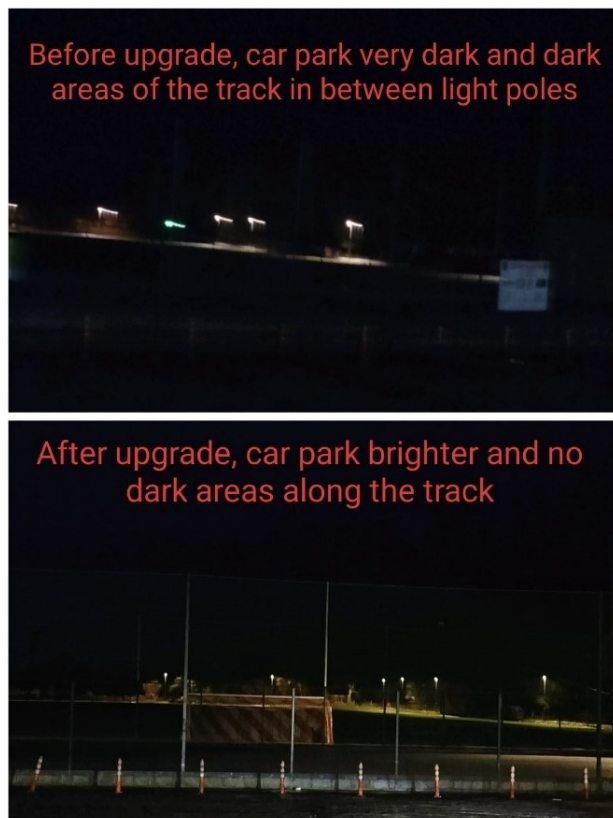
projects were completed Portumna GAA's grounds resurfacing, Beagh GAA' Lighting and the Tennis Court at Caltra National School and Tommy Larkin's Lighting project which was completed. Site visits have been conducted in first weeks of January and continuing into February to include Comhar Chuigeal Teoranta's site visit to the community hall upgrade for the 14th of February. Finalisation of the 8 remaining Clár projects is being guided by the Community and Rural unit at present.

A Claim to the Dept for Rural and Community Development was submitted in January 2025 for €58,000 at present. A Further 4 projects are nearing completion at present and the Unit has been very busy finalising inspections in the month of January for the 15 new projects commencing to get them off the ground. At present there are 23 live projects in the Clár programme.

The 15 projects awarded funding under the 2024 CLAR programme will be implementing activities in 2025 and will be supported by staff in rural development on procurement, governance and claims. Site visits are continuing, and the Webinar scheduled for Tuesday February 4th 2025 had to be postponed until later in the year, so meeting the groups on the ground and the telephone where possible were used to navigate the newly approved grantees to commence works.

LOCAL COMMUNITY DEVELOPMENT COMMITTEE (LCDC)

The next LCDC committee will be meeting on Tuesday 25th February at 10.30 a.m. via MS teams. Items on the agenda include Performance Review of Annual Plans 2024, Annual Plans for 2025 for Galway East, Galway West and Galway Islands, Case Studies and LCDC Annual Report 2024.

LOCAL ENHANCEMENT PROGRAMME 2025

Galway County Council has received funding of €213,601 from the Department of Rural and Community Development under the Local Enhancement Programme 2025 (previously Community Enhancement Programme). This funding is comprised as follows:

- a) €175,000 in capital funding for carrying out necessary repairs and improvements to community facilities, energy efficiency type projects, purchase of equipment for community use, etc. In line with previous years, the LCDC will endeavour to allocate 30% of this fund towards small grants of €1,000 or less to maximise its benefit to small grassroots groups. Grants over €1,000 will be targeted at improving facilities in disadvantaged areas, projects which support improved access for people with disabilities/reduced mobility, enhancing community participation for other disadvantaged or marginalised groups, and improving energy efficiency of community facilities to reduce ongoing costs.

- b) €30,515 in current funding to support small grassroots groups such as Men's/Women's Sheds with their non-pay running costs, e.g. insurance, electricity, heating, etc.
- c) Galway County Council administration fee for the scheme - €8,086

The funding available under a) and b) is now open for applications with a closing date of 28th February 2025. Funding recommendations of the LCDC will be submitted to the Department of Rural and Community Development by the end of March 2025, for funding announcements by the Minister for Rural & Community Development in April 2025. All capital projects will be required to be completed and grants drawn down by end of 2025. Applicants should apply via our online grants system at <https://galwaycoco.submit.com/>

In some cases, stress can give you some motivation to get on with a task, such as revising for an exam or doing more training before a sports event.</p> <p>This short-term stress can be positive as it drives you to do the best you can. However, sometimes you might feel disproportionately stressed about something that shouldn't cause you too much stress, such as speaking in front of an audience. Public speaking can be nerve-racking, and if it doesn't go well you may feel frustrated or embarrassed. However, objectively nothing terrible will happen when you give a speech. Everyday events shouldn't cause you to feel so stressed that your mental health starts to suffer. If stress lasts for a long time, or you feel stressed about small things, this emotion is no longer healthy. People who have chronic or severe stress may start to notice worrying physical or emotional symptoms, and so it is important to manage this.</p>

By supporting the Healthy Ireland vision, the newsletter contributes to creating healthier environments and encouraging healthy lifestyle behaviours.

Some of the topics recently covered include an overview on stress, coping with stress and how to recognise the negative impacts of stress. Additional articles provide healthy snack options, tips on cooking healthy food, and advice on losing weight safely. Other articles have focused on social connection and 'ways to connect' in the workplace, at home, and within the community, as well as 'Other News' covering events happening in the broader community.

At the end of each newsletter, we invite those who wish to submit an article or receive the newsletter to email us

directly. There is also a mailing list for community groups or individuals working in the sector, which they can join if they wish. We look forward to sharing more content in the coming months through the Healthy Galway newsletter for 2025.

COMMUNITY DEVELOPMENT AND SOCIAL INCLUSION

AGE FRIENDLY PROGRAMME

A joint meeting of Galway City and County Older People's Council took place on 12th February 2025 as the preliminary consultations on the development of an Age Friendly Strategy for the City & County. Thereafter, focus group consultations will be arranged across the County through the PPN in tandem with an online survey, which will be followed by targeted consultation sessions with key stakeholders such as the Age Friendly Alliance Members and other agencies required to deliver actions. Staff from the Community Department also attended a Networking Meeting for all Men's Sheds in the County to provide information on funding schemes appropriate to the development of Men's Sheds which are vital hubs for wellbeing and social inclusion at local level.

COMHAIRLE NA NÓG

A report on the 2024 activities of Galway County Comhairle na nÓg will be submitted to the Department of Children, Equality, Disability, Integration & Youth during February, setting out the research and awareness done by the Comhairle Members on their chosen topic of "Mental Health – Teachers Awareness and Responses to Student Mental Health".

COMMUNITY SUPPORT SCHEMES 2025

The closing date for the Community Support Schemes 2025 has been extended to Monday 10th February 2025, due to widespread disruptions to power and connectivity as a result of Storm Éowyn. As a result of the extended closing date, it is anticipated that recommendations for funding will be brought to the March Plenary Meeting.

PUBLIC PARTICIPATION NETWORK (PPN)

The PPN will be seeking Expressions of Interest this month for a number of voluntary positions on the PPN Secretariat, which is the primary advisory committee for PPN activities between Plenary Meetings. PPN Representatives on the Strategic Policy Committees attended training in Sligo on 7th February which was organised for all representatives from the North-West Region. The PPN Workers attended a Networking Meeting on 10th February which provides vital linkages and support with other PPN's, the Department of Rural and Community Development, and other stakeholders.

66 applications were received. The total requested amount is €163,122.47.

A peer panel of artists will meet at the end of February to assess and award the €30,000 available.

The 2025 round of funding for Creative Communities opened in mid-December and ran until the 5th of February. Four online info sessions were held to provide guidance and advice to applicants.

A total of 58 applications were received for grants ranging from €2,000 to €8,000. This was then shortlisted down to 38 applications which were brought to the assessment panel.

From this assessment 12 were chosen with a total spend of €65,025. The panel favoured projects which demonstrated strong community involvement in their development and execution.

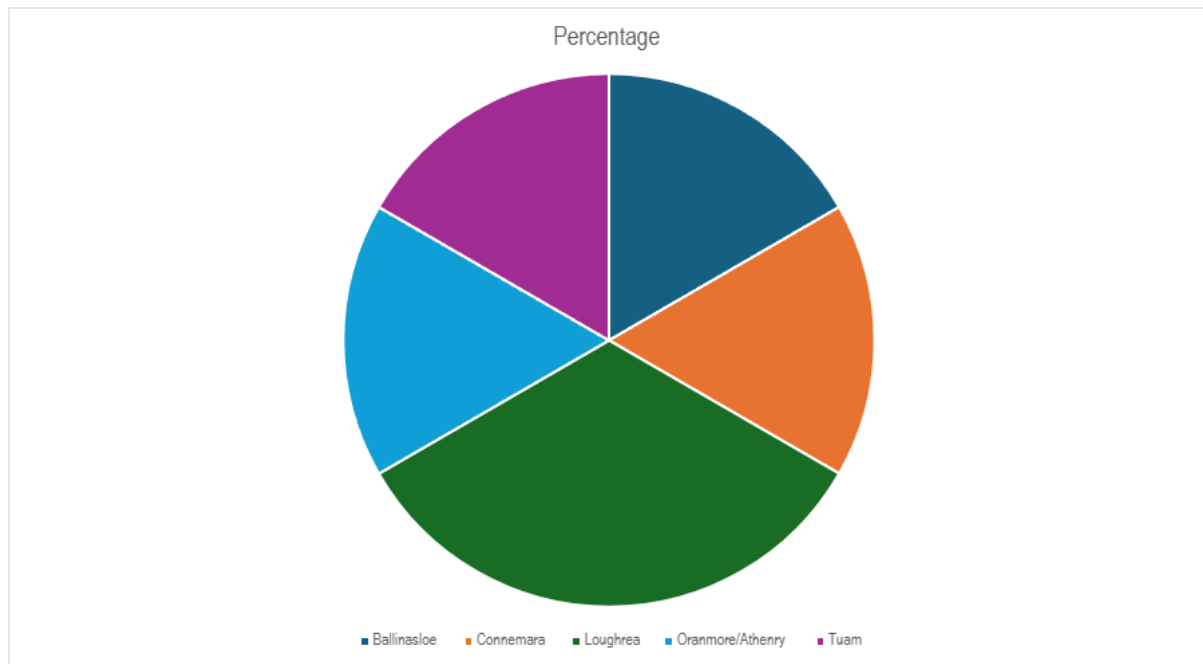

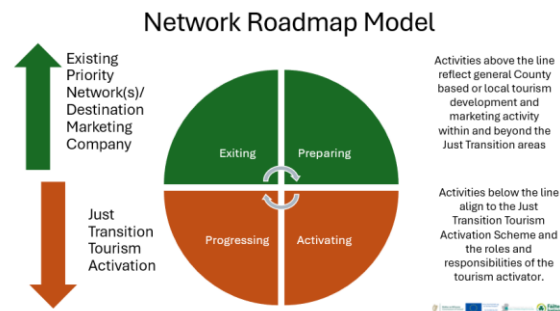

All applications for the Just Transition Fund will be assessed by April.

The activators are now working on the Network Roadmap. At a meeting in Tullamore, a framework template was created for the region, which can be tailored by each activator to suit the needs and activities in their functional area. This network development helps build capacity at the network, encouraging the

LITTER MANAGEMENT PLAN UPDATE



An update on progress in the Litter Management plan 2023-2025 was outlined to the Councillors in the Loughrea MD on February 12th. Progress in relation to education and awareness, partnership and community support, litter prevention and control measures and enforcement was outlined.

POLYTUNNEL AT ARD SCOIL MHUIRE BALLINASLOE

Galway County Council supported Ard Scoil Mhuire to put a polytunnel in place in their school as part of a garden project. This is part of a garden development which will teach students about environmental issues and the effects of climate change and educate about the benefits associated with growing their own food (Farm to Fork approach).



BURIAL GROUNDS

Part 8 planning approval for an extension to Leitir Moir burial ground was granted by the Conemara MD council members in January. The extension will provide an additional 193 burial plots and 10 urn plots. Tender documents will now be prepared for construction this year.

Plans for an extension to the Rinvile burial ground outside Oranmore were outlined to the members of the Loughrea MD at the February meeting. The National Monument Service and HSE were consulted during the design process. A planning application will be submitted this year.

There has been notable damage within several Galway County Council's burial arising from the recent Storm Eowyn. Clearance and repair works will be organised over the forthcoming weeks.

We supported the Heritage Section with submission of 12 applications to the National Monuments Service seeking Community Monuments Funding relating to works to be carried out in Council owned burial grounds.

DOG CONTROL

DOG WARDEN SERVICE

1 fixed penalty notice issued under the Control of Dogs Act 1986 As Amended during the month of January 2025. This was on foot of a significant sheep kill in the Eyrecourt area where 6 sheep were lost in a dog attack. A responsible dog ownership campaign carried out in the area by the dog warden service and a post on sheep worrying by dogs highlighted on our social media platforms also.

769 dog licences purchased during the month of January, with 250 of those licences purchased online.

XL BULLY BAN

Regulations introduced on October 1st, 2024, prohibit the importing, breeding, selling and re-homing of XL Bully type dogs.

Since February 1st, 2025, it is illegal to own an XL Bully type dog without a 'Certificate of Exemption', or proof of application for a 'Certificate of Exemption' issued by the local authority.

Galway County received 24 applications for a Certificate of Exemption to own an XL Bully type dog during the month of January. 32 applications have been received since the regulations came into effect on the 1st of October, 2024. 2 of the applications received could not be processed as they were received past the deadline of the 1st of February 2025. 17 Certificate of Exemptions have been issued by Galway County Council to date.

COUNCIL DOG SHELTER

Upgrade work to Galway County Council's dog shelter is nearing completion with the provision of 7 additional kennels which will greatly improve help futureproof the service in respect of the health and wellbeing of the dogs in our care as well as assisting in improving health and safety for the dog wardens, shelter keeper and veterinary personnel on site. This work is being carried out with funding provided by the DRCD as part of the Dog Control Initiative 2024. A full update on the works when completed will be provided to the Plenary in next month's report

WATER QUALITY AND ENFORCEMENT

AGRICULTURE

LAWPRO carried out a catchment assessment of the Failmore_010 high status objective waterbody in October 2024 after a red dot notification was received from the EPA. A red dot notification is where there is a marked deterioration in a water quality monitoring point. LAWPRO's catchment assessment included water testing which detected active ingredients for sheep dip. Galway County Council conducted some farm inspections in the area in January 2025. 3 farms were inspected with one farm having a dipping tank close to a water



course. This dipping tank contained spent dip and there was evidence on-site of an overflow to a drain which led to a stream tributary of the Failmore river. Water testing was also carried out with results due shortly. Enforcement of the GAP regulations will be carried out as necessary.

SHEEP DIPPING UNIT

SECTION 4 DISCHARGE LICENCES

A meeting took place in Kylemore Abbey with Kylemore management team, MKO environmental consultants, Molloy environmental, caretakers and Galway County Council to discuss compliance with the premises section 4 wastewater licence. It was agreed that daily plant checks, increased sampling with extra locations and increased plant de-sludging would be implemented in 2025.

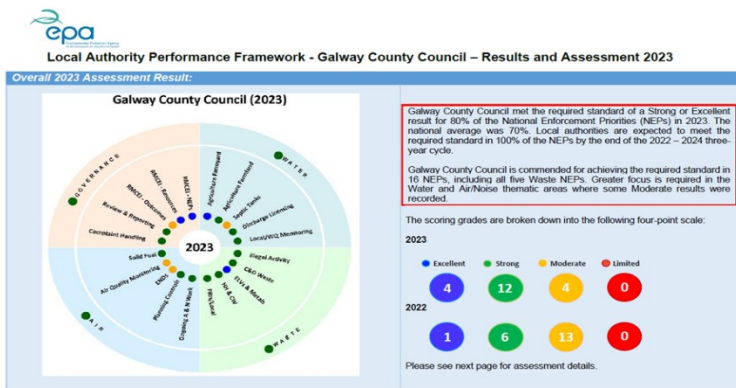


Figure 1 Map of Kylemore Abbey showing Water Sampling Location SW1, SW2, SW3

The annual returns to the EPA are due at the end of February. Work commenced on this in January. Under the water section, work carried out during 2024 in the following areas are reported:

- Pressures from Agriculture (Farmyards) - slurry/soiled water collection and storage

The Plan for 2025 needs to be finalised which will outline the number of inspections, etc., that will be undertaken in the different areas.

6 on-site inspections of domestic wastewater systems were carried out, made up of 2 verification inspections where works have been completed, and 4 site visits following up on progress with closing out older advisory notices. 3 advisory notices have been closed since these inspections.

RMCEI

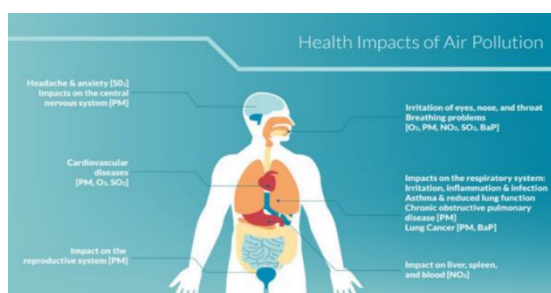

Approximately 1060 waste complaints and approximately 30 air complaints were received by the Environment Section in 2024.

SOLID FUELS

The enforcement of the Solid Fuel Regulations 2022 is ongoing throughout this winter heating season. Over 35 retail premises have been inspected so far. Of the 35 approx. 75% were found to be compliant with selling only approved fuels. All premises found not to be compliant are being issued warning letters outlining the non-compliance found. A register of all solid fuel retailers and transporters is being maintained. Online market sites are also being requested to remove any non-compliant products for sale in the county.



NOTICES ISSUED / FILES SENT FOR PROSECUTION

6 litter fines issued under the Litter Pollution Act by the Community Warden service during the month of January.

2 Section 18 Notices were issued in January, and 5 files were referred to the Law Agents for Prosecution.

STORM ÉOWYN / FALLEN WIND TURBINE.

Environment staff inspected the site of a fallen wind turbine at Indreabhán. The site in question is one of the oldest wind farms in the County and was constructed 25 years ago. There are 5 turbines at this location, one of which was blown over in the storm. The entire turbine was destroyed and approx. 120L of oil was released into the bog. The owner of the site was contacted, and a Section 14 Direction letter was issued directing him to obtain the services of a specialist consultant in contaminated land before any clean up works were carried out.

The owner has since obtained the services of a specialist, and they are liaising with the Council.



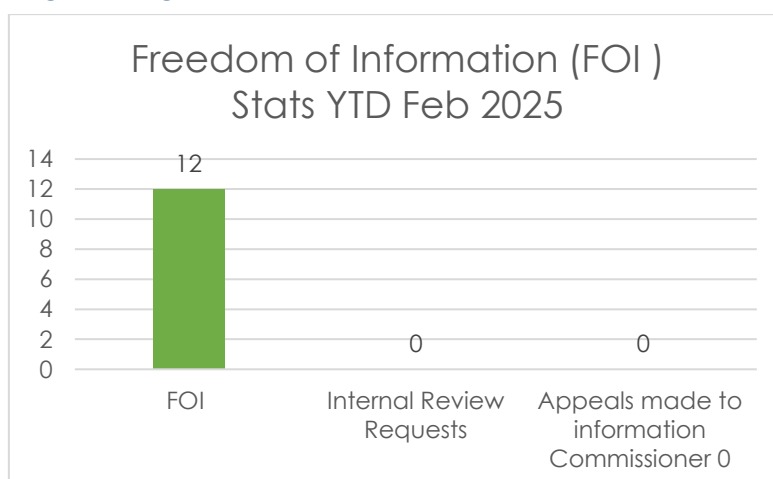

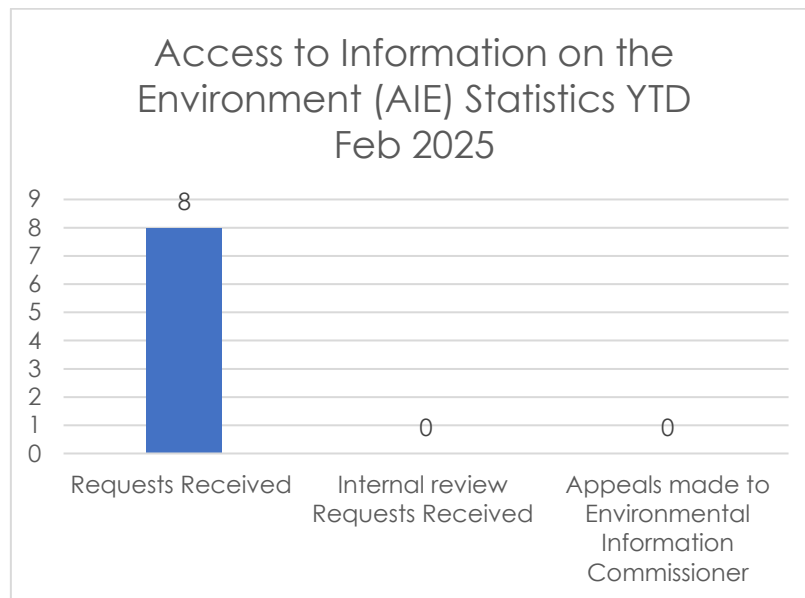

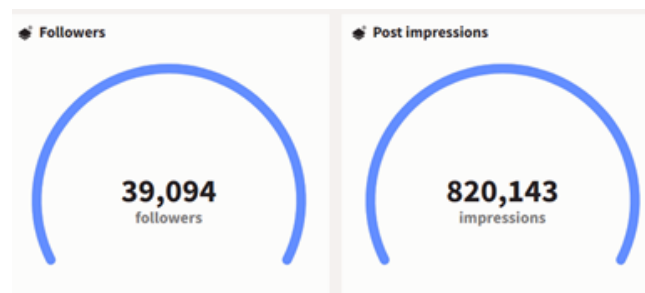
OVERVIEW OF SOCIAL MEDIA ACTIVITY

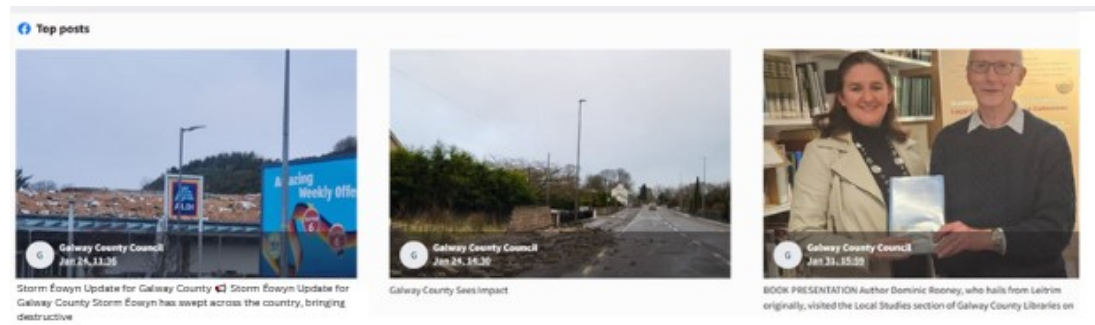

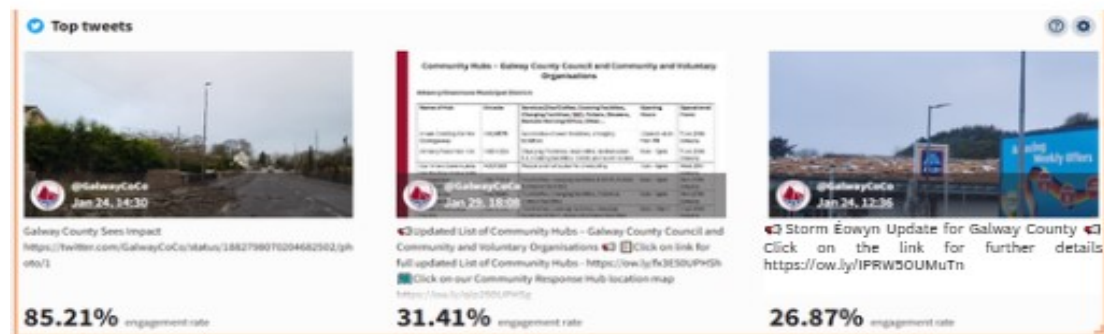

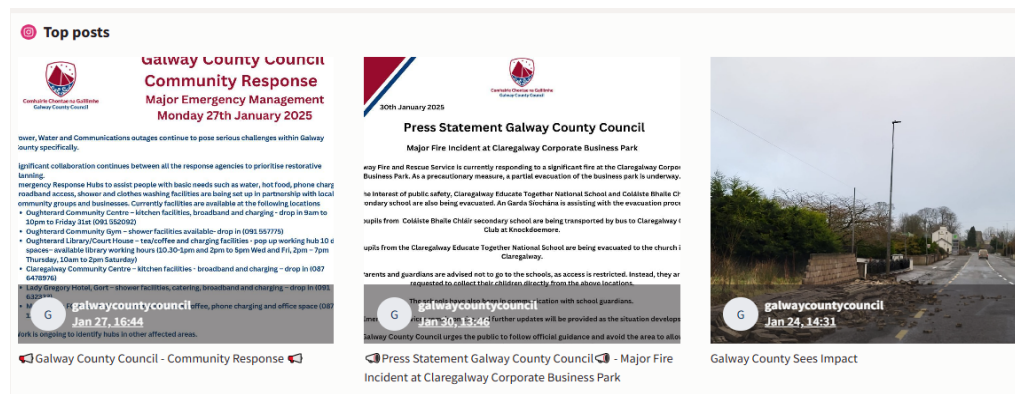

GAELTACHT SCHOLARSHIPS 2025

We have received a huge volume of applications for the Gaeltacht scholarships (aimed at secondary school level students) residing within the functioning areas of Galway County Council.

By the extended closing date for applications (due to Storm Eowyn) of Friday Jan 31st 4pm, we had 228 completed applications for 2025. This is an astounding increase from the 85 applications received in 2024.

We have also managed to get another Irish Summer college onboard with us this year which is greatly appreciated and through much persistence on the part of our Irish Officer. The new college is Coláiste Cholumba based in An Cheathrú Rua. This addition will follow Coláiste Chonnacht, Coláiste Lurgan, Coláiste Chamuis, Coláiste Chiaráin, Coláiste Sheosamh, Spleodar and Coláiste na nOileán that are all currently participating in the scholarships since 2024.

Students will get the opportunity to spend 3 weeks submerged in the Gaeltacht and the Irish language.

The draw will take place on the 24th February after the Galway County Council Pleanary meeting @4pm in the Atrium as part of our launch event for the Program of activities for Galway County Councils' Seachtain na Gaeilge countywide. We look forward to having as many of our staff and Elected Members join this event.

Galway Public Libraries provide an extensive array of services to the community and fulfil the key actions set out in national policy on the provision of an inclusive library service. January was busy in our branches with **38,252** visits and just under **39,000** issues of books across the network.

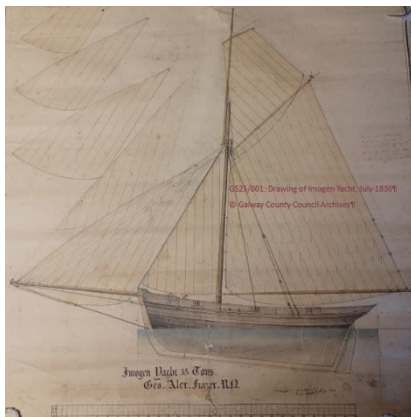
HEALTHY IRELAND EVENT

ARCHIVES

Galway County Council Archives acquired (by transfer from Local Studies) this wonderful drawing of the yacht *Imogene*, dated 1836 (GS25/001). Research into Frazer



and *Imogene* has revealed that Captain George Alexander Frazer, of the Royal Navy (1817-1852), used the *Imogene* while surveying the east coast of Ireland from Kingstown (Dún Laoghaire) to Wicklow. Dublin Corporation awarded the Freedom of the City on Frazer in 1841, ‘*in testimony of his skill and diligence in effecting a survey of the coast between Kingstown and Wicklow*’ (Warder and Dublin Weekly Mail, 2 Oct 1841).

Frazer had a distinguished career working with the Admiralty’s Hydrographical Department, surveying much of the Irish coast. He is reported to have had his headquarters in Galway while surveying the west coast. Further details are available on the Archives [online catalogue](#)

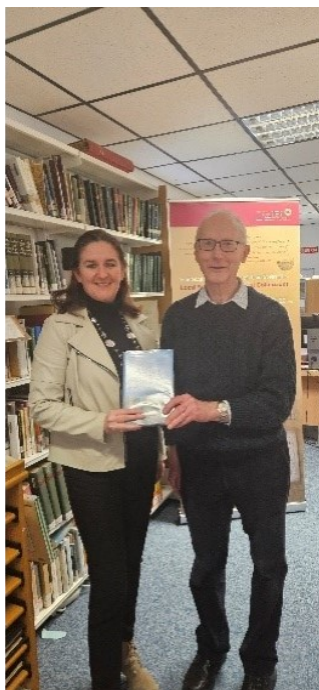
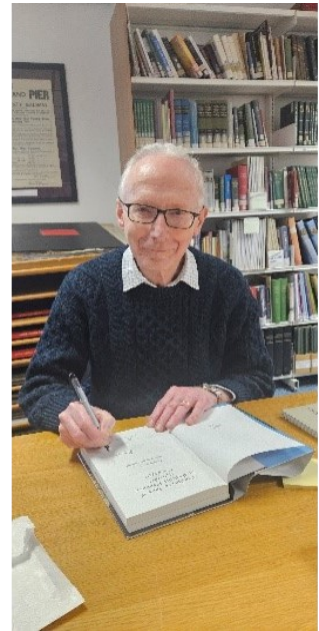
LOCAL STUDIES

The Local Studies department at the County Library HQ specializes in providing information on a variety of topics, with a focus on local history, genealogy, and general reference queries. It serves as the primary repository for the library’s local history materials, which include books, newspapers, and maps.

The department plays a crucial role in preserving and providing access to information about the specific locality. Key functions include historical research, genealogy, community information, preservation, educational support, and digital access.

AUTHOR VISIT TO LOCAL STUDIES

Author Dominic Rooney, who hails from Leitrim originally, visited the Local Studies section of Galway County Libraries on Thursday to present a copy of his excellent and most interesting book on the life and times of Sir Frederick Hamilton, a Scottish nobleman, who acquired a grant of land in Leitrim, in the plantation of 1620. The book, which is beautifully illustrated, describes Sir Fredericks life and adventures in Ireland, and his eventual return to Scotland, where he died a ruined man in 1647. The book gives a very good insight into life in Ireland during those troubled times. Dominic presented his Book to the County Librarian, Elizabeth Keane. Dominic also signed the copy.

BALLYBANE LIBRARY

In early January we hosted the exhibition of Panels detailing the work of various social and community groups led by the city Social Prescriber Suzanne McKane.

This exhibition culminated in a busy afternoon on Wednesday 15th of January when we



hosted an afternoon information session attended by Suzanne, Staff from local groups such as Cope, the Galway City Partnership, the local Drug and Alcohol Addiction support, Suicide Awareness and indeed

Ballybane library staff during which speakers gave information to local people on the different services available to them.

During January we are also exhibited the Positive Ageing Local Heroes Panels
It is worth noting that five of the 13 local heroes are from the Eastside of the city, a source of great pride for our community.

We liaised with local Public Health Nurses, inviting new mothers to meetings in the Maker Space on the first three Tuesdays of each month. These sessions were well attended by local women.

Our Chat Circle offered a safe space for newcomers to practice their English. The ever-expanding Craft Group on Wednesdays provided two hours of companionship for local women to craft and chat and our Creative Writing Group, and two adult book clubs continued at pace, while our children's and teen book clubs thrived, all hosted and supported by library staff.

Our Friday morning Rhyme Time, run with the support of Music Generation Galway, was well attended.



Fusion Fridays, where library staff hosted creative art sessions with local children, were popular, and beautiful artworks were created and proudly taken home.

Our Saturday morning Story time and Feed the Fish has been a very popular and our Bi-lingual stories supported by our diverse community.

Family Coding Sessions: Corrib Coding provided popular family coding sessions every Saturday in January.

Centenary Celebrations: Award-winning author Jonathon Creasy held a workshop for budding writers from Galway.

HSCL Programme: The HSCL programme encouraged parents from local DEIS schools to participate in community events, including relaxing yoga sessions every Thursday.

Tech Classes: Ruth Kelly from GRET B returned to run six free computer and smartphone classes for locals.

Music Unveiled: Galway Music Residency's 'Music Unveiled' session with Contempo on January 29th was a great success.

St. Brigid's Day Crosses: On January 29th, library staff hosted workshops for making St. Brigid's Day Crosses with reeds. Approximately 30 adults and 20 children attended, including members of the Brothers of Charity services and children from the ACE afterschool program run by Galway City Partnership.

Memory Teddies: Kitty's Memory Teddy workshop on Thursday mornings has been very popular. Participants bring clothing from a deceased loved one to incorporate into a teddy bear made from recycled materials. Due to high demand, another 6-week session is planned for late February. Ballybane library ran a successful competition in which local children were invited to present a piece of art expressing the magic they experience in their local library. Mentoring Programme: Lastly, we are facilitating a mentoring programme between local poet and Ireland Reads Ambassador Rita Ann Higgins and one of our neighbouring Brothers of Charity service users, published poet Dan Doherty. Dan has received Creative Ireland funding for this project.

BALLINASLOE LIBRARY

Ballinasloe Library & Europe Direct Centre collaborates with several external groups in the town and surrounding areas. These groups have repeat bookings with us, some visiting 2-3 times a week, while others come once a week. The library offers them a free place of warmth and relaxation, with friendly and welcoming staff. The following groups continue to join us on a regular basis:

HSE Brothers of Charity Service The Brothers of Charity met in the library every Tuesday and Thursday in January. They created art and relaxed in our Reception Room, with 6-8 participants attending twice a week. They also had a weekly 40-minute Chair Yoga class, totaling 88 participants in January.

Fáilte Isteach English Conversation Classes The Fáilte Isteach English Conversation Classes with qualified tutors remained popular, with a total of 58 participants.

The Crafty Girls The Crafty Girls, a local ladies' group from Ballinasloe, met weekly on Wednesdays to knit, sew, and chat. This group includes women of all nationalities and abilities.

GALWAY CITY LIBRARY

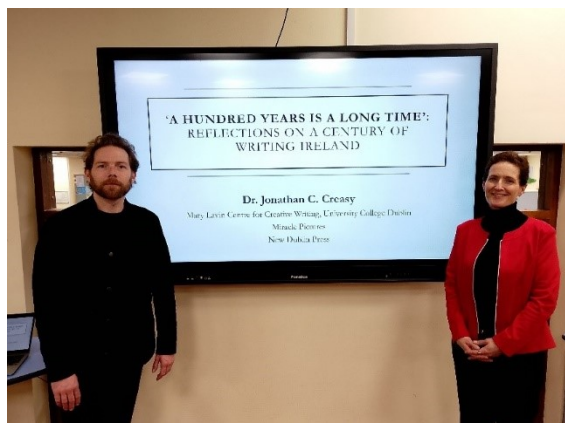


The monthly Foróige anime/manga session took place, with seven (7) young people taking part in the session, where they engaged in a series of artistic activities as shown in the photo opposite.

Galway City Library hosted the annual Galway Advertiser Art Competition Awards ceremony. Eighty-two (82) people (parents and children) attended the event, which was opened by Mayor Peter Keane, with speeches from Declan Varley, editor of the Galway Advertiser, Tom Kenny of Kennys Bookshop and Art Gallery. The event was sponsored by Kenny's Bookshop and Art Gallery and Creagal Art. Photographs from the event were featured in the following week's Galway Advertiser.



Dr. Jonathan Creasey, founder of the New Dublin Press, and teacher on the Creative Writing faculty in University College Dublin at the Mary Lavin Centre for Creative Writing delivered a talk titled "A hundred years is a long time: Reflections on a Century of Writing Ireland". Twenty-two (22) people attended the event.

Artist Michelle Buckley exhibited her new collection of equine art at Galway City Library. Michelle is a radiation therapist, and she is currently studying painting at Jim Kavanagh's Art School in Annaghdown. This was her first time exhibiting at Galway City Library.



Traditional willow-weaver Sarah Jenkinson facilitated two St. Brigid's Cross workshops (one at 11am and one at 5:30pm), teaching participants to make both the modern 4-sided cross and the old pagan 3-sided cross and spoke about the history of each. These workshops were funded by Galway City Council and Creative Ireland.

Artist Caroline Coyne Concannon from Inishbofin opened a new art exhibition at Galway City Library. Her photographs capture the quiet beauty and lingering memories of island life and its forgotten spaces, where nature and time reclaim what was once filled with life.

Our monthly Classical Culture streaming performance took place on Friday 7th February. Feedback was very positive from all who attended.

LOUGHREA LIBRARY

Loughrea Library has been very active, hosting a variety of events: we held Local craft group meetings on a weekly basis and monthly Toddler Storytime and Play-Doh Fun, book club meetings, and LEGO Free Play. The first LEGO Free Play on February 6th was attended by 15 children with their parents/guardians.

Loughrea Library hosted two class visits from St. Ita's National School for book exchanges and craft activities, with 46 students attending

ORANMORE LIBRARY

Although the weather was bad it wasn't a deterrent to the teachers who brought their students for book exchanges to the library, we had 18 class visits from the local schools, 16 from primary and 2 from the local secondary school. The bi-monthly meeting of An Ciorcal Comhrá recommenced in January and is proving very popular. This initiative, which began last year, is in collaboration with Gaeilge Locha Riach.

The Poetry Group and Lego Free play were both well attended, and we hosted a wonderful exhibition to mark 100 years of Galway Public Libraries.

From January 7th-21st, Oranmore Library hosted a wonderful exhibition to mark 100 years of Galway Public Libraries. The Staff of Oranmore Library presented an opportunity to all the children who visited the library from mid-January to help create a cloak for St.

Brigid. The concept involved each child decorating a square of paper which when pieced together would create a mosaic effect cloak. The response has been wonderful with lots of beautifully decorated

squares produced. Once the cloak is constructed, it will produce a beautiful display and represent a wonderful community effort to create something to celebrate St. Brigid's Day. The photo shows a work in progress!



TUAM LIBRARY

We have been very busy with staff-led monthly book clubs. Attendance remains high for the three book clubs: Adult, Young Adult, and Audio. We are also pleased to have established a new craft group, which is quickly becoming popular.

The staff of Tuam Library continue to contribute a weekly 500-word article to the 'Library Corner' of the Tuam Herald. Topics include newly published books on local history and the latest science fiction releases.

We continue to host Rhyme Time every Wednesday at 11 am. In January, we held four sessions with 63 children attending. LEGO Free Play on Saturdays remains popular with all ages, benefiting the development of motor skills, creativity, and imagination.

Community Connects takes place every Friday from 11 am to 12 pm, offering an open session for the public to enjoy tea and conversation.

Trinity Primary School visits the library weekly on Wednesdays from 9:30 am to 10:30 am, with rotating classes. This initiative successfully introduces students to the library, with an average of 20 students plus teachers/SNAs attending each week.

Soundbites, a gathering of local musicians, storytellers, singers, and poets, occurs on the last Thursday of the month from 1 pm to 2 pm. Attendance averages between 40-50 people and includes a mix of those playing keyboards, guitars, violins, as well as singers and poetry reciters.

The Breastfeeding Group meets on the second Thursday of the month from 10:30 am to 11:30 am. All are welcome, and the group is facilitated by a local HSE public health nurse/midwife.

Artist Emer MacDermot and her daughter Maisie Gilpin's joint exhibition, exploring the relationship between generations, has garnered significant interest in the town.



WESTSIDE LIBRARY

Westside Library continued to support a range of community activities, including the Ukrainian after-school family craft sessions (Galway City Partnership), Parents Health& Wellness Classes, the Speckled Eggs dance group, the Alzheimer's Support Group, and



Cuidiú breastfeeding support. These groups regularly utilized our auditorium space.

We also welcomed two new groups: the Community Choir and the newly established English Conversation Class, designed for language other than English (LOTE) speakers and run by Galway City Partnership. Both groups meet weekly at Westside Library.

LIBRARY LORE LAUNCH

The Library Lore project, celebrating the centenary of Galway Public Libraries, held its official launch. Members of the creative writing groups from Ballybane and Westside recited poems they had developed during the workshops. Renowned Poet Gerry Hanberry then presented the collaborative poems from each group, followed by the accomplished artist Hilary Morley unveiling the artwork created to accompany them. The event was a great success, attracting a large audience who enjoyed the poetry, which will eventually be displayed in the participating libraries.



WELLBEING CALENDAR LAUNCH

Galway City Partnership, in collaboration with local agencies, launched the 2025 Wellbeing Community Calendar at a special information session. This event provided the public with details on available activities, support groups, and resources within the Westside community

HOUSING – RESPONSE TO STORM ÉOWYN

The Housing team met three days in advance of Storm Éowyn, to plan and enact precautionary measures to endeavour to minimise the impact on our vulnerable clients.

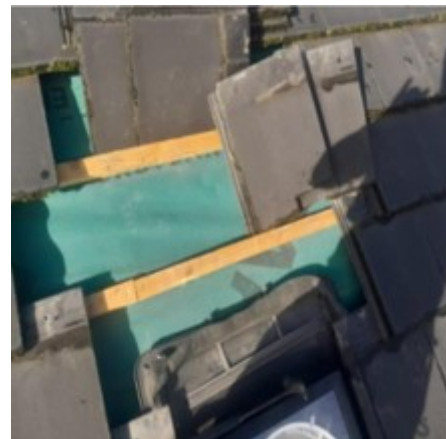
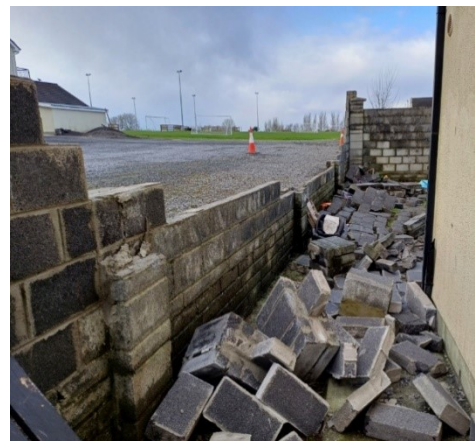
Preparatory action taken included:

- Implementing our Halting Site Evacuation Plan in collaboration with Brú Bríde and Galway Traveller Movement.
- Galway County Council Housing Liaison Officers and staff in Homeless Section contacted all occupants who were known to the Council who are residing in demountables, caravans or mobile homes across the County, approximately 40 households, and advised them to seek shelter in an alternative location in advance of storm Éowyn.
- In co-operation with the staff of Brú Bríde shelter was made available for the occupants of halting sites in the County area in Tuam town. The Homeless Section, with the assistance of COPE Galway, sourced short-term temporary accommodation for the most vulnerable clients who had limited supports available to them, to ensure their safety.
- The Housing Maintenance Team arranged for a clean-up operation involving the removal of debris and refuse at the halting sites to prevent any risk to occupants living in the sites.
- Preliminary arrangements were made by Housing Maintenance staff with contractors who committed to responding to repair needs identified by the Council after the storm.

Immediately in the aftermath of the storm, when it was safe to do so on Saturday morning, several Council housing staff commenced a comprehensive County-wide visual review of all Council properties to identify where repairs were required and the level of repairs required, this task was completed within a few days. Alongside this review, reports of damage to Council property from tenants was recorded and collated to enable a programme of works to be initiated. Storm related repairs were recorded as necessary in approximately 450 properties. Several contractors and Council staff commenced the task of repairing damage caused by the storm on Monday with work nearing completion and minimal disruption caused to tenants. The prompt action of the staff of the Housing Section has also ensured that Council owned assets were protected from more extensive damage. It is notable that Council tenants have been complimentary to Council housing staff and contractors regarding their rapid response to the situation.

The Council's housing section participated in the Community Response over a period of weeks alongside the Community Department. Practical support was provided to vulnerable Council tenants who were impacted by a power outage such as sourcing accommodation and linking in with other agencies and local organisations to provide supports dependent on the presenting needs of the tenants. Regular updates were provided to Galway County

Council's Crisis Management Team, which met daily for number of weeks, on the status of housing repairs and outlining responses to identified needs of tenants.



AFFORDABLE HOUSING

44 affordable homes are under construction in Baile Chláir (Claregalway) and are being made available for sale by Galway County Council. The homes are amongst 61-housing units being delivered in the Garraí Na Gaoithe development, which is the first turnkey housing scheme to include affordable housing in County Galway under the Government's 'Housing for All' policy. The units also are amongst the first affordable homes to be developed in County Galway since 2013.

Applications for the 44 units, which comprise 2 two-bed, 27 three-bed and 15 four-bed houses, will be accepted via an online application portal from Monday 24th February 2025 at 10:00am until the deadline of Monday 17th March 2025 at 5:00pm. All applications will be initially prioritised in order of date and time received.

Located on the Lakeview Road, the Garraí Na Gaoithe scheme also features a crèche and is located close to local amenities in Baile Chláir.

CAPITAL BUILD PROGRAMME

PLANNING CONSENT (PART 8 APPROVAL) FOR PROPOSED HOUSING DEVELOPMENT AT COSMONA, LOUGHREA

A Part 8 planning application (LA 08/24) was lodged on 18th October 2024 for a proposed new residential development at Cosmona, Loughrea consisting of:

The construction of 56 new housing units, comprising of: including 44 no. houses and 12 no. apartments, comprising of 44 no. houses, including:

- 16 no. 2 bedroom houses
- 25 no. 3 bedroom houses
- 2 no. 4 bedroom houses
- 1 no. 5 bedroom house

and 12 no. apartments, including:

- 6 no. 1 bedroom apartments
- 6 no. 2 bedroom apartments

Varied boundary treatments and landscaping works; all ancillary site development works and site services necessary to facilitate the proposed development including an Uisce Eireann pumping station and parking for the existing graveyard adjacent to the west of the site adjacent to a Burial Ground which is a national monument NIAH GA105-066

The consultation period concluded on 2nd December 2024. There were 9 submissions/observations (1 duplicate) received. One submission related to the confirmation of feasibility from Uisce Eireann. The other 8 submissions were from residents of the neighbouring Hazelwood including a petition signed by 63 residents. These submissions largely related to the proposed connectivity between the two estates, in particular, the anticipated traffic relating to the two new vehicular accesses from the new development onto the existing Hazelwood entrance/exit road.

All submissions were acknowledged and considered. A revised layout removing the two proposed vehicular connections was submitted by Housing to the Planning Department on 27th January 2025.

This revised layout was recommended for approval in the Part 8 Chief Executive's Report, which was brought before members of Loughrea M.D. at the February Meeting (10/02/2025).

Members of the Loughrea M.D. approved the Part 8 proposal subject to the following amendments:

- The proposed pedestrian connectivity between the proposed development and the existing Hazelwood estate is removed
- The boundary wall between the two estates will remain in-situ at its current height (and will not be replaced with a new lower boundary wall)

It was agreed that a revised drawing will be issued, to the members of the Loughrea M.D. and the planning Department, which illustrates the Part 8 with amendments, as adopted.

PROPOSED HOUSING DEVELOPMENTS IN ATHENRY - CULLIARBAUN AND GORT MHAOILIR UPDATE

An Architect Led Full Integrated Design Team was appointed in July 2024 to provide design consultancy services for the Provision of Social Housing Developments at both Cullairbaun and Gort Mhaoilir in Athenry, for delivery through the accelerated delivery programme Stages (i) to Stage (v) - delivery by Design and Build.

The successful Architect Lead was Studio PKA with an integrated design team comprising Mulcahy Mc Donough (QS), SDS Design Engineers (Civil & Structural Engineers), CBS Consulting Engineers (Mechanical & Electrical Engineers) and Fact Fire Consulting Engineers (Fire Engineering Services).

This integrated design team is in the process of compiling the Part 8 planning for both schemes. The proposed Cullairbaun scheme will comprise of the development of 10 housing new units and a community based residential facility suitable for 4 residents and a staff member. This Part 8 proposal is due to be lodged at the end of this month (Feb. 2025). The proposed Gort Mhaoilir scheme will comprise 43 new housing units and will be an extension of the existing Gort Mhaoilir estate. This Part 8 proposal will follow and is due to be lodged next month (March 2025).

EXPRESSION OF INTEREST FOR LEASE/LICENCE OF COMMUNITY BASED RESIDENTIAL FACILITY AT CULLIARBAUN ATHENRY

An expression of Interest 'seeking an organisation to lease/licence a new community based residential facility, in Athenry' was advertised on the local newspaper (Connacht Tribune 06/12/2024) and on e-Tenders with a closing date of 10th January 2025.

A subsequent evaluation took place on 17th January and the *Brothers of Charity Services Ireland* were determined to be the most suitable service provider.

Four housing applicants from the Galway County Council housing waiting list will be accommodated in this facility with all care, support and tenancy sustainment provided by the Brothers of Charity.

An agreement will be drawn up by legal teams and a lease/licence will be put in place between Galway County Council and Brothers of Charity Services Ireland/Peter Triest AHB

STAGE 1 APPROVAL FOR PROPOSAL AT VICAR ST., TUAM

Galway County Council has identified a need to provide supported accommodation in the County of Galway for vulnerable people experiencing chronic homelessness. Short-term accommodation is necessary for people who have a history of rough sleeping and is particularly in demand during the Winter period. The provision of medium-term accommodation that is accessible is essential to provide for persons with complex, multiple issues, particularly those with a dual diagnosis of mental health with another issue. The proposed development at Vicar St., Tuam includes both a stand-alone Cold Weather Response Unit providing accommodation for 11 no. people and three self-contained Medium Term Accommodation Units providing accommodation for 8 no. people. By co-locating these units, it allows for a cost saving in staffing and management requirements. The proposal includes management facilities to accommodate the number of staff likely to be on duty at any time. It also includes a separate room for individual consultation and storage for bedding and linen. A private outdoor space is provided in a courtyard to the rear of the site which will be landscaped with a mix of hard and soft finishes. The proposal for this multi-purpose facility was developed in consultation with both the technical and homeless staff of Galway County Council with input from the regional lead - Galway City Council and two Non-Governmental Organisations providing homeless services in County Galway. Further to discussions with, and a Stage 1 submission to, the Department of Housing Local Government and Heritage, approval to proceed with this proposal was received on 7th February 2025.

PURCHASE OF GROVE HOUSE, ENNIS ROAD, GORT

Galway County Council has acquired a property known as 'Grove House' from the Health Service Executive (HSE) Estates. The property is located on the Ennis Road in Gort. It comprises a detached residence which was originally two neighbouring semi-detached houses. It was converted into one residence for use as a care home but has lain vacant for approx. ten years. The interior of the property is in a poor state of repair due to it being vacant for an extended period. It requires modernisation and refurbishment from a use, functionality and sustainability perspective. There is a large back garden accessible through a concrete driveway to one side and the overall the site comprises 0.12 Hectares/0.3 acres. An initial site visit was undertaken by the housing section and the feasibility of the property and associated site for development of social housing is currently being assessed.

PHYSICAL DEVELOPMENT, FIRE & EMERGENCY & CLIMATE CHANGE

ROAD OPERATIONS

Roads crews have been extremely busy working on the clean up after Storm Éowyn. The immediate works in each MD involved removing trees from the road carriageways to facilitate immediate passage of traffic.

Communication was challenging due to the level of impact on telecoms infrastructure, but crews had been prepared in advance to expect significant damage. Crews moved out after the storm when the Red alert period had lapsed and, on a risk-assessed basis. Crews and MD technical teams and Roads HQ teams worked throughout the weekend. The re-opening of routes was prioritised from National Roads through Regional and to Local Roads, reflecting the strategic nature of routes and the level of traffic. This then had to be balanced with the need to open blocked routes to facilitate people in getting access and egress to their homes. Whereas in previous weather events roads were affected by one or two falling trees, the MD crews were now experiencing multiple trees fallen across very short sections of road. The clearance therefore has taken much longer than we have experienced from storm events in recent years. The Roads teams continue to assess the broader scale of damage, boundary walls, public lighting, road edge damage, signage and surfacing.

The clean-up work in all MDs is continuing. All roads are now open but a second and third pass on many routes is required to complete full clearance, to pick up on damage signs etc. Our parks were also badly affected; particularly the Palace Grounds in Tuam, and the Cow Park in Clarinbridge. Work will continue for some time yet at these locations, as the scale of tree damage is very extensive.

Galway County Council will undertake a review report on the Storm Response and that report will also feed up to the National Review.

ROADS CAPITAL (NEW ROAD CONSTRUCTION WORKS)

The tender for the realignment of the R332 in Kilbannon was published on eTenders on 14th January with a return date of 26th February 2025.

The tender for the western section of the Athenry Northern Ring Road (elbow section) was published on eTenders on 16th January 2025 with a return date of 3rd March 2025.

ISLANDS GRANTS

In response to a query from Galway County Council Roads HQ, the Dept. of Rural and Community Development has indicated the Minor Works Grant scheme for our islands will be available again for 2025. The Council has compiled a draft list of projects it is seeking to address, and we look forward to the opportunity to make our case for the progression of these works.

WINTER SERVICE VEHICLES UPDATE

As a first step in the move to pre-wet treatments TII provided funding for the acquisition of 2 number permanently mounted salt spreaders with brine spreading capability.

Procurement of these vehicles has been completed and they were delivered and brought into service in January 2025.

The trucks were supplied by Romaquip, based in Birr, Co. Offaly and the cost of just over €500,000 will be fully recouped from TII. The acquisition of these new purpose-built vehicles will be an important addition to the Winter Service fleet and the efforts to ensure strategic routes are kept open during cold weather events.

ROADS PROGRAMME 2025

The Department of Transport notified local authorities of their annual roads programme allocations on Friday 14th February. Galway County Council has received an allocation of €43,650,160, which is an increase of €3,723,860, or almost 10%, on the 2024 allocation. The draft Roads Programme for 2025 will now be finalised on the basis of the allocations advised to us. This will be presented to Councillors for their consideration at the Municipal District Meetings in March, together with the other items that form the Schedule of Municipal District Works.

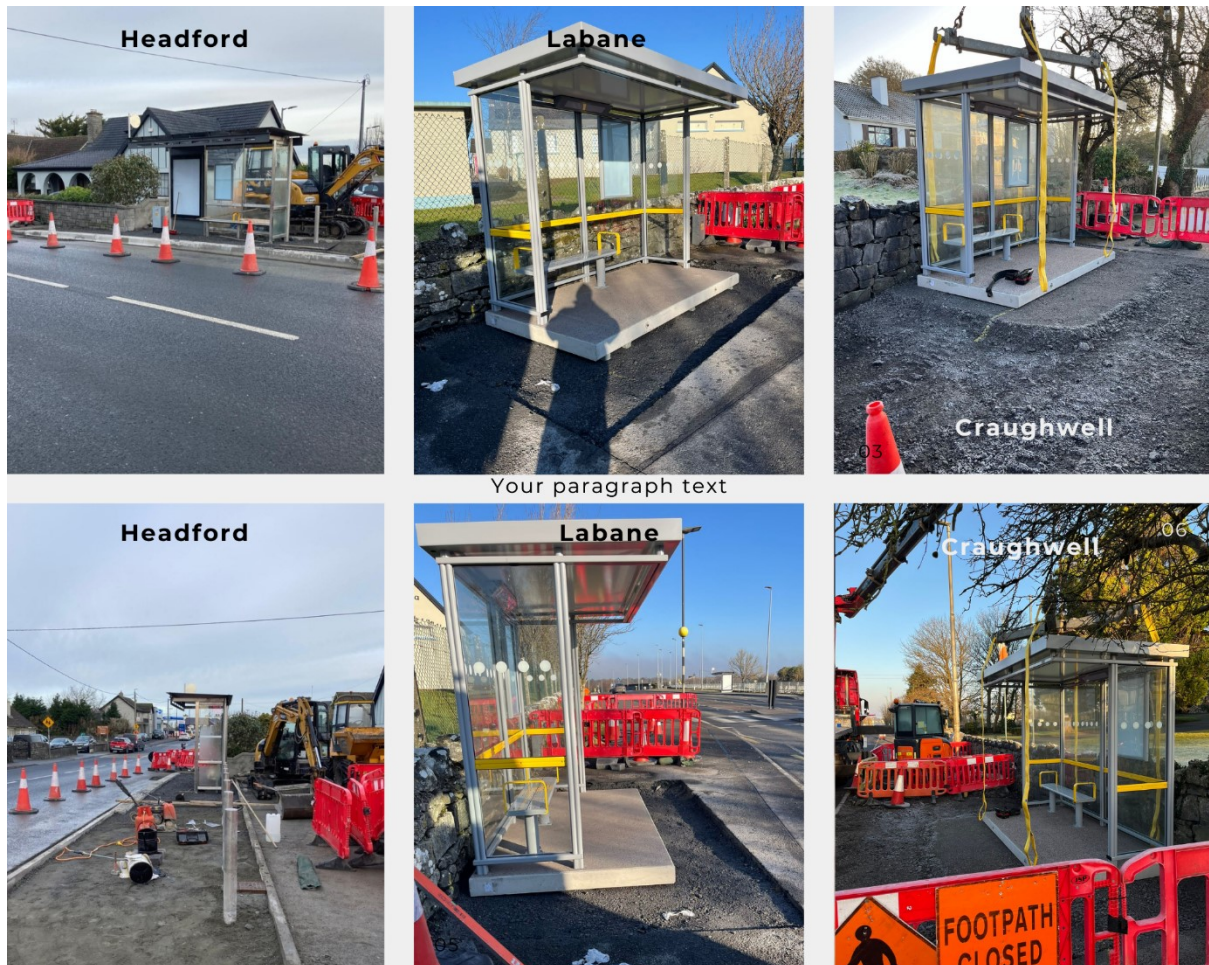

The construction of Labane and Craughwell bus stop commenced on 4th February. The works are to accommodate the installation of bus shelters



ROUND 1 SAFE ROUTES TO SCHOOL (ORANMORE AND ATHENRY SCHOOLS)

The schools are Calasanctius College, Oranmore, Gaelscoil de hÍde, Oranmore, Scoil Iósaif Naofa, Oranmore, Scoil Chroí Naofa, Athenry & Athenry Boys National School. 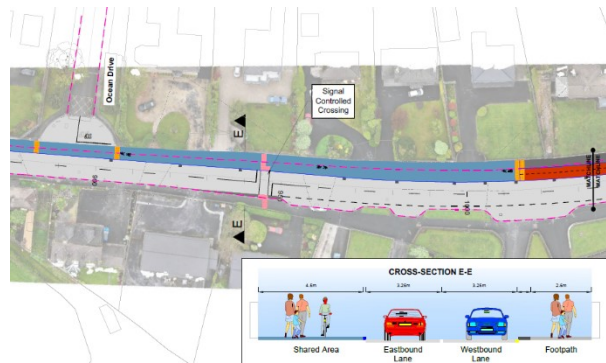

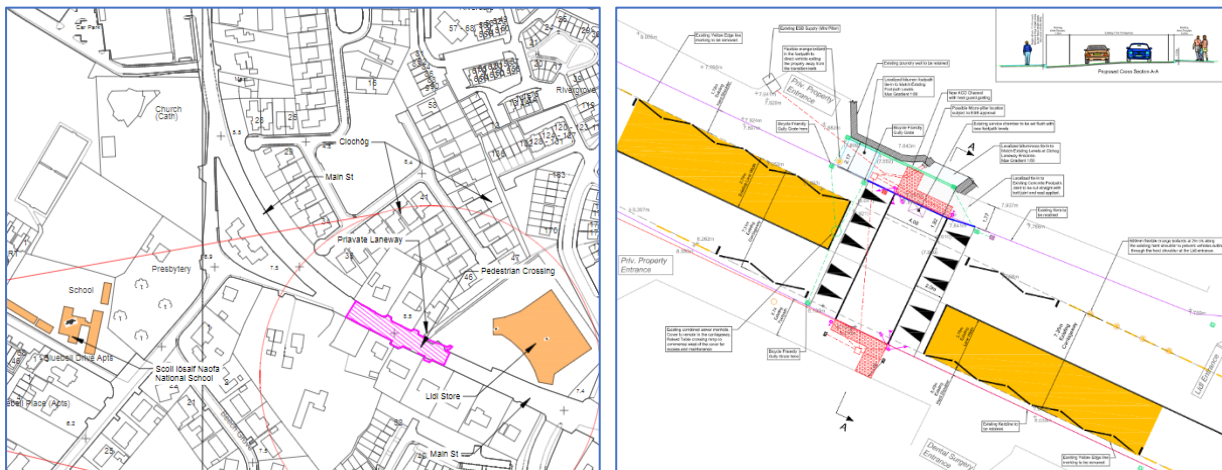

The service provider will then have 10 working days to contact their customer and provide a resolution, otherwise, if this does not occur or if the customer is not satisfied with their service providers response, the customer can then contact ComReg's Consumer Team who are available via the details below between 8.00am to 8.00pm Monday to Friday and 9.00am to 1.00pm on Saturday (excluding public holidays).

CLIMATE CHANGE

CLIMATE ACTION TRAINING



Galway County Climate Action Unit in partnership with Roscommon County Council and GRETb have organised a free online Local Climate Action Course for community and voluntary groups. This free online 6-week course will cover topics on Biodiversity, Energy, Food & Waste, Recycling and Transport. Denise Feeney, the Community Climate Action Officer, will also be talking about the Climate Action Fund and will give guidance to community groups on how to apply and what to apply for. The course started on the 29th January

from 7.30pm – 9pm and will take place online every Wednesday for 6 weeks.

MOUNT LUCAS RETROFITTING RIG

Galway City Council and Galway County Council, in collaboration with Mount Lucas Construction Training Campus, will welcome the arrival of an innovative training facility from the 17th of February to the 7th of March 2025. The rig will visit three locations across County Galway, providing training and information sessions on energy efficiency upgrades to in Shantalla, Ballinasloe, and the University of Galway Campus. The rig offers a hands-on approach to training on nearly zero-energy building standards and retrofitting techniques. The initiative will include NZEB Fundamental Awareness, Retrofit for Households, and the Retrofit for Schools Programme, which expert tutors will deliver. It provides a unique opportunity for members of the local community to access accredited training and practical demonstrations right on their doorstep.

Improving building energy efficiency is critical to addressing climate change, and initiatives like this not only equip people with essential skills but also demonstrate the practical benefits of retrofitting in increasing home comfort and reducing carbon emissions. The rig showcases cutting-edge technology, is powered by solar PV panels and is equipped with a working heat pump and ventilation system, making it entirely self-sufficient. Its design lets participants see first-hand how emerging technologies are installed and function in real-world settings.

YOUTH CLIMATE ASSEMBLY

In conjunction with Youth Work Ireland Galway, we will be hosting our 2nd Youth Climate Assembly on the 26th of February in Athenry. Our 1st Assembly, which was held in May 2023, was one of the first events of its kind to happen at a local level in Ireland. These assemblies provide a space for young people from secondary schools and youth organisations across the county to gather to discuss Climate Action. The participants will be introduced to policies, projects and research being undertaken in County Galway to tackle the Climate and Biodiversity Crises and will be encouraged to initiate positive change through their school/youth group/community.

SUPPORT FOR ENERGY MASTERPLANS

The Sustainable Energy Communities (SECs) programme supports communities in the transition to a low carbon society. Communities are provided with a range of supports as they develop along SEAI's three-stage journey of "Learn- Plan -Do". The "Plan" stage is the development of local Energy Master Plans (EMP). The EMP grant allows communities to undertake a baseline assessment of their energy use, carry out energy audits of a number of homes / community buildings / local businesses, and helps them to identify the most suitable renewable energy solutions for them. This information supports applications for projects under various funding streams including the GCC Community Climate Action Fund. GCC supports the completion of the EMP including through the provision of Bridging Finance and procurement support to SECs. The EMP grant is 100% funded by SEAI but it is a

retrospective grant once the Energy Master Plan is completed. The provision of Bridging Finance removes the financial barrier for communities.

FIRE & EMERGENCY MANAGEMENT

OPERATIONS

The information below is based on January data from West Regional Control Centre (WRCC). Galway Fire and Rescue Service (GFRS) had 255 turnouts to 215 Incidents. That is an increase of 56 incidents on 159 the previous month. 73 were fire incidents, 132 were special service incidents (road traffic collision (RTC), Automatic Fire Alarms (AFA's), flooding, storm damage, etc.) and 10 were standby either in station or at a central location. Of those incidents, 40% were attended by Fire Service resources within 10 minutes of alert, 37.44% were attended between 10 and 20 minutes and 22.56% were attended in over 20 minutes. The average turnout time for the Full-time station in Galway City was 2.3 minutes and for county retained stations was 7.37 minutes.

There was a significant increase in incidents and turnouts in January by comparison to December 2024. This increase is due to 2 significant events in the latter part of January – Storm Éowyn and the fire/incident at Xerotech in Baile Chláir. During Storm Éowyn, in the interest of the safety of our firefighters, all personnel were brought into station on standby from an hour before to an hour after the Red Weather Warning for wind. Post the storm, there were a significant number of special service incidents, primarily water supply of critical infrastructure (hospital, nursing homes, etc.)

In the context of the incident at Xerotech in Baile Chláir, the incident ran from 0700hrs on the 29th January to 1715hrs on the 31st January. Over the course of the incident there were attendances of crews from Galway City, Athenry, Gort, Loughrea, Tuam and An Cheathrú Rua, with on occasion Gort, Loughrea, and/or Portumna providing standby services in central locations around the county due to the significant amount of resources deployed at the incident.

CAPITAL PROJECTS

LOUGHREA FIRE STATION

Following Senior Management Team approval, the revised application under Part 8 of the Planning and Development Regulations for the proposed Loughrea Fire Station was submitted for publication on the 11th October 2024. The public consultation process ended on the 22 November 2024. The Chief Executive's report was submitted to the Loughrea Municipal District meeting On the 09 December 2024 and the Part 8 application was passed



by the elected members. The final design will now be completed, and it is hoped to tender for the main contractor in early 2025.

PROPOSED NEW FIRE STATION LOUGHREA

BRIGADE MECHANICS WORKSHOP ATHENRY

A Request for Tender for the Design Team has completed and was received on the 13th September 2024. The tender assessment board met on the 2nd October 2024 to consider submissions, and the Most Economically Advantageous Tender has been identified. All required information has been submitted by the preferred tenderer, and the Design Team Contract is scheduled to be signed by mid-February 2025.

MAJOR EMERGENCY MANAGEMENT

Colas (CBE West) Oranmore

A multi-Principal Response Agency review commenced of the Upper Tier COMAH (Control of Major Accident Hazards) Site at Colas in Oranmore, with a Principal Response Agency & relevant stakeholder meeting early in April. The required statutory exercise was conducted on the 23 May 2024 in Oranmore and led by Galway FRS. The updated External Emergency Plan was advertised for Public Consultation on the 11th October 2024 and latest date for

submissions is the 15 November 2024. As there were no submissions the EEP has now been adopted and was signed and circulated by the PRAs at the end of December 2024. A further blind mobilisation test is scheduled for the site in early 2025 and will further test the response of the Local Competent Authorities and GFRS.

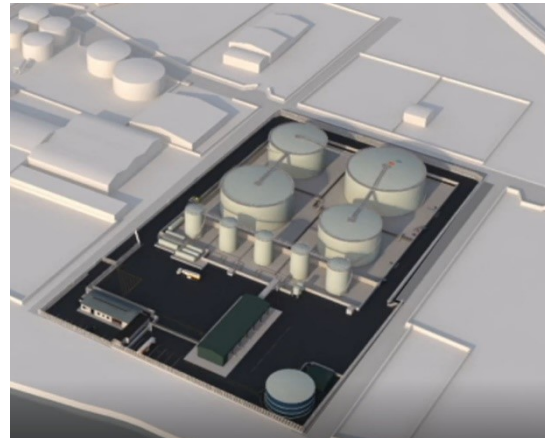

ISLAND RESPONSE PLAN AND AER ARAN EXERCISE

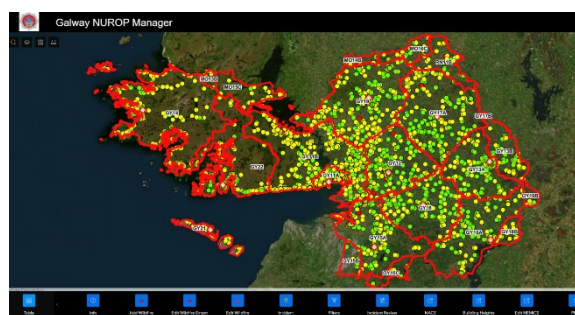
A multi-Principal Response Agency review commenced of the Offshore Island and Island Airport Response Plan, with a Principal Response Agency & relevant stakeholder meeting early in September. The required statutory exercise was conducted on the 28th Nov 2024 in the dual locations of Connemara Airport, Indreabhán and Inis Mór Airport. The draft exercise report was circulated Dec 2024 to each PRA for consultation and will be signed early 2025.

CHEMICAL BIOLOGICAL RADIOLOGICAL NUCLEAR & EXPOLOSIVE MATERIALS EXERCISE (CBRNE)

A CBRNE exercise led by An Garda Síochána and Galway Fire and Rescue Service (GFRS) was conducted at Galway airport on the 12th December 2024. The exercise was designed to test response to a large CBRNE event in a large shopping centre and to test GFRS remote capability and GFRS / National Ambulance Service (NAS) decontamination procedures. Participants included the HSE /NAS, Defence Forces Explosive Ordnance Disposal and An Garda Síochána Emergency Response Unit. Further inter-agency discussions and additional exercises will be conducted in Quarter 1 2025.

NUROP AND SEVERE WEATHER EVENT MANAGEMENT SYSTEM

Work continues on the NUROP (National Unified Risk Operating Platform) and SWEMS (Severe Weather Event Management System). A new NUROP Manager Application has been released which includes risk scores for every domestic and non-domestic building in the county. SWEMS has recently been extended to Galway City Council. SWEMS was successfully used in Galway County Council for recent numerous storms.



PREVENTION

The information in the following is based on the January 2025 figures. The Fire Authority received 18 Fire Safety Certificate applications and issued decisions on 7 applications. 3 Disability Access Certificate applications were received, and decisions made on 5 applications. 1 new licence was issued in January and 23 inspections were conducted.

CIVIL DEFENCE

In the New Year, the country was faced with Severe Weather Alerts ranging from Orange to Yellow for severe cold and potential snow covering various counties. Galway Civil Defence were notified by the HSE through the HSE Emergency Management Office to provide standby assistance to HSE Public Health Nursing and Palliative Care Nursing from Galway Hospice getting to visit vulnerable and critical patient who needed care during the weather alert. Also, for the transportation of patients to hospital appointments and home by Civil Defence Ambulance crews.

Members were tasked over a 4 day period to Glenamaddy, Dunmore, Loughrea, Woodford and Portumna. Members also provided assistance to Tipperary Civil Defence collecting a dialysis patient from Nenagh to UHL in Limerick for vital treatment. A Public Health Nurse

was also taken to meet the ferry at Cleggan from a location in Tuam to visit Inishbofin. Assistance was also provided in delivering meals to Ballinasloe Social Services. The Civil Defence Officer (CDO) and Assistant Civil Defence Officer (ACDO) attended Severe Weather Crisis Management Team (CMT) Meeting to keep updated on events and further potential requests from various agencies.

In the second week of January 2025 training resumed in all units continuing with their training development

On the 19th January 2025, the ACDO was alerted by An Garda Siochana for assistance in searching for a missing person on the Indreabhán Coastal area. A drone crew responded and as stood down later the evening.

On the 22nd January 2025, the CDO and ACDO attended a National Directorate for Fire & Emergency Management (NDFEM) CMT meeting with the risk of a potential storm tracking towards the country.

On the 24th January 2025 the country was put on Red level Alert for Storm Éowyn. Civil Defence was put on standby to assist any request resulting from the extreme damage caused by the event.

Assistance was provided to the HSE in transporting vulnerable persons to respite care.

Assistance was provided to Galway County Councils CMT in collecting and delivering generators and transporting families to hotels and return journeys as requested.

The CDO is also a member of the Galway County Council Community Response Forum which have met daily since activated.

On the 30th January 2025 Galway Civil Defence were requested to provide support to Galway Fire and Rescue Service at an industrial incident in Baile Chláir. 1 ambulance, 1 minibus, 1 Control Unit, 1 drone and 1 * 4x4 vehicle responded with 10 members.

Members remained onsite to provide vital assistance to the Fire Service until 22.40hrs that night.

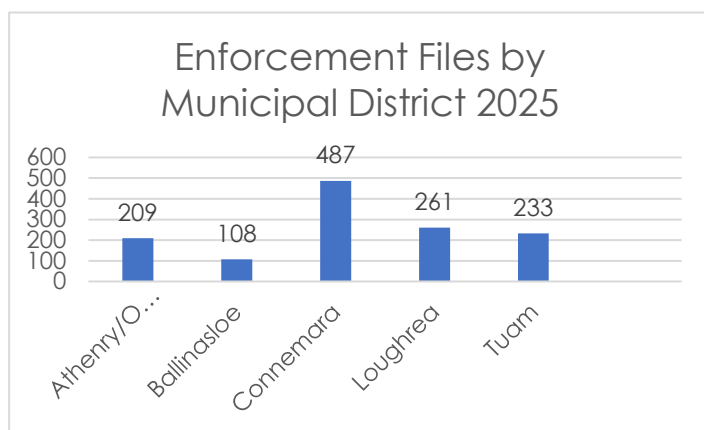

These scoped in land parcels identified on the Annual Final Maps 2025 will be charged as of the **1st February 2025**. Such requests must be made to Galway County Council between **1st of February to the 1st of April 2025**. Rezoning requests provide an opportunity for an exemption from the RZLT on Final Map.

THE ANNUAL DRAFT MAP - PUBLISHED ON 1ST FEBRUARY 2025

The Draft Annual Maps 2025 includes only two settlements, **Athenry and Loughrea** as both plans were reviewed and agreed in 2024. Athenry and Loughrea scoped-in sites **will not** be liable for **RZLT until 2026**.

REGENERATION SCHEMES

ATHENRY

TOWN CENTRE FIRST (TCF)

The Athenry Town team have been working closely with the TRO and Consultants LUC in the initial stages of evidence gathering for the TCF plan. An online survey has been published and can be accessed on <https://athenry-town-centre-first-plan.com/>. A further team meeting and workshops are to be arranged.

RRDF PROJECT

Following a detailed application by the Regeneration Team, Athenry was granted €6,075,518.40 Rural Regeneration Development Funding for the Athenry Public Realm Enhancement Scheme Phase1 and the redevelopment of Somers House Burke's Lane to provide a Community and Enterprise Hub. The regeneration team has progressed the

project with the appointment of consultants for the Public Realm project. Current programming forecasts construction to commence late-2025. As part of the contract a Community Liaison Officer will be appointed to manage engagement with local stakeholders both prior to and during works. A tender has been prepared for the appointment of consultants to deliver the construction of the Somers House redevelopment; tenders are due to be returned by 07/02/25. Once appointed the design team will deliver the process through detailed design, tender and construction phases.

LOUGHREA

LOUGHREA TOWN HALL

After securing additional funding from the Department of Rural and Community Development, Galway County Council has appointed Finna Construction to undertake the works. A formal contract signing took place in the Loughrea area office on Monday the 13th of January. Works have commenced on site. Finna Construction are in ongoing discussions with the adjoining landowner in relation to gaining access to the rear of the building. The situation remains unresolved.

LONG POINT

The Regeneration team are working with Consultants Helena McElmeel Architects to deliver the redesign of the Long Point swimming area in Loughrea Town. An Bord Pleanála have issued a request for further information. The consultants have issued the Regeneration Team a revised fee proposal to undertake this work. Approval is to be sought for this cost



uplift. An Bord Pleanála have granted an extension until May 2025 to respond to further information request.

BIRDS EYE VIEW OF THE LONG POINT REDEVELOPMENT PROJECT INCLUDING THE VIEWING PLATFORM

CLIFDEN

A Part 10 planning application has been submitted to An Bord Pleanála for the Public Realm project for Clifden Town Centre, Harbour Park and Beach Road Quay. Plans and particulars can be viewed online at <https://consult.galway.ie/en/consultation/clifden-public-realm-enhancement-scheme>. The deadline for observations has now passed and 43 submissions were received. Case is due to be decided by 01/05/2025. To date there has not been a request for further information.

OBFA architects Ltd are progressing with the development of the Town Trail Strategy. A Co-design workshop took place on the 23rd of January 2025 to receive feedback from the public and identify high level Design Principles for the trail. The event was well attended and

brought to light several concerns of the local community such as the need for consistent signage and universal access. OBFA architects will continue with the design.

PORTUMNA COURTHOUSE

Works are currently progressing ahead of programme at Portumna Courthouse. Issues getting the ESB to site for the new connection will possibly affect the hand over date. An Expression of Interest for operators of the Café in the Courthouse was published mid-October, with formal tender documents issued at the end of January. Funding is in place through the DRCD for the appointment of a 3-year temporary post of Business Development and Operations Manager for the facility. This post has now been advertised with a closing date of the 27th of February. This post will also manage the Loughrea Town Hall and Tuam Town Hall once completed.

Portumna Public Realm

The Portumna Public realm enhancement scheme part 8 planning application is approaching submission readiness.

Engagement is continuing with a view to purchasing town centre lands to increase the provision of off-street parking to support town centre businesses.

GORT

GORT PUBLIC REALM

The Gort Public Realm scheme is ready to be submitted as a part ten planning application to An Bord Pleanála. We are engaging with our Law Agents to purchase lands in the town centre for additional car parking space.

GORT TOWN HALL:

The proposal for further renovation of the Town Hall including roof repairs and interior works to support the community activities was one of the proposals listed in the Town Centre First plan for Gort. The Town Regeneration Officer liaised with the Town Team to secure funding under the Historic Structures Fund from the Heritage Council. Consultants were appointed to work with the Gort Town Hall Management Committee to get all necessary drawings and statutory consents in place for the renovation of the Gort

Town Hall. This phase of the project is now completed, and the building is ready for a capital funding application next year.

TUAM

TOWN HALL

The Regeneration Team has completed the first stage of the tender process for Tuam Town Hall. Two tender responses have been received and initial evaluation has taken place. Once appointed the design team will deliver the process through detailed design, tender and construction phases.

STATION QUARTER THRIVE FUNDING

Galway County Council is working in partnership with Iarnród Éireann and to deliver a transformational masterplan for the Tuam Station Quarter. Reddy Architecture and Urbanism have been formally appointed to develop the masterplan. The design objectives for the Tuam Station Quarter are centred around transforming a derelict area into a vibrant, mixed-use development with a strong sense of place and local identity. The first public consultation has taken place and will inform the design process as we progress with this project.

TUAM STATION BUILDING: REPURPOSING, RENOVATION AND EXTENSION

The renovation and extension of the Tuam Station Building has been designed inhouse by the Regeneration Team with a view of submitting a part 8 planning application in March 2025. This has been presented to the MD members and showcased at the public consultation event. Capital funding will be applied for the Tuam Station House project in May 2025 through a final round of THRIVE funding.

AN CHEATHRÚ RUA TOWN CENTRE FIRST PLAN

The Regeneration team is working in collaboration with Údarás na Gaeltachta and the Town team and wider Local community to deliver a Town Centre First Plan for An Cheathrú Rua. Allies and Morrison have been appointed and the inception meeting has taken place on site.

BALLINASLOE

Following on from the successful funding application by the Regeneration team under THRIVE funding to the Northwest Regional Assembly to fund the delivery of a dedicated Town Centre First Plan focusing on the historic core and Fair Green identifying potential projects for future funding applications. The tendering process is now complete, and the Regeneration Team have appointed The Paul Hogarth Company (Ireland) limited to work with the Town Regeneration Officer, the Town Team and local community to progress the plan process. A Pop-up event was held on Tuesday, February 11th from 1pm - 7pm at Ballinasloe Enterprise Hub. This first phase of consultation will close this Sunday, February 16. Funding available now for heritage projects in Galway

THE HERITAGE COUNCIL'S COMMUNITY HERITAGE GRANT SCHEME IS NOW OPEN FOR APPLICATIONS

The Heritage Council is now accepting applications from voluntary or community groups and not for profit non-governmental organisations in County Galway for its [Community Heritage Grant Scheme 2025](#).

In 2024, the scheme funded several projects in County Galway including the following:



Ballinderreen Community Centre to preserve the rich history and heritage of Ballinderreen GAA through the stories past and present, provided support to the Roundstone Community Development Council to produce a bilingual exhibition and a digital heritage trail on the history and heritage of Roundstone and Ballygar Tidy Towns for their Conservation works to the orchard walls and outbuildings at the Castle Kelly estate in Ballygar; Glinsk community Development Society Limited for Ballinakill Abbey

Conservation Project; Donaghpatrick Kilcoona Heritage Society for a A LiDAR survey of Knockma's unstudied archaeological landscape, largely hidden by tree canopy; Milltown Community Council for an Energy audit of the lighting and the purchase of exhibition and interpretation materials for their museum and Friends of Tuam Heritage for Digital recording of St Mary's Church of Ireland Graveyard Tuam & community workshops.

This year a broad range of project types are eligible for funding under the scheme including:

- Conservation works to collections, objects or places, including natural heritage projects e.g. control of invasive species or habitat restoration works; conservation works to buildings, including churches; stabilisation works to ruined structures;
- Surveys, reports, plans, and audits to inform the future management of buildings and monuments, habitats, collections, or objects.
- Accessibility projects that make heritage activities more accessible for people with disabilities e.g. building ramps, automatic doors, handrails, tactile interpretation
- Projects that help people engage more with their heritage e.g. interactive maps, videos, virtual exhibitions, podcasts, websites
- Purchase of specialised equipment e.g archival boxing for vulnerable documents, monitoring equipment for humidity or light, interpretation/multimedia equipment, specialised software

- Projects that address the heritage of minority groups e.g an oral history project documenting Traveller heritage
- Training in traditional skills and crafts e.g. workshops on skills such as roofing, thatch, dry stone walling etc.
- Citizen science projects on environmental conservation

The minimum grant that can be requested through the scheme is €500. The maximum is €25,000.

The variety of applicants who successfully secured funding in 2024 demonstrates the positive impact the scheme has across the heritage spectrum. A full list of projects funded last year is available from below:

TRADITIONAL FARM BUILDINGS GRANT SCHEME



The Heritage Council, in partnership with the Department of Agriculture, Food, and the Marine, manages the Traditional Farm Buildings Grant Scheme. The scheme's principal objective is to ensure that traditional farm buildings and other related structures that contribute to the character of the landscape and are of significant heritage value are conserved in active agricultural use as well as other related structures such as walls, cobbled yard surfaces, walled orchards, dungsteads, millraces, gate pillars and gates.

The 2025 Traditional Farm Buildings grant scheme will open for applications on 30 January 2025. Applicants must apply online for this grant scheme via the Heritage Council's online grant system. They do not provide or accept paper forms.

The closing date for receipt of completed online applications is **5pm Monday 10th March 2025**.

WHO IS ELIGIBLE TO APPLY FOR THIS SCHEME IN 2025?

The Scheme is only open to farmers in the Republic of Ireland participating in and accepted into one of the following Department of Agriculture Food and the Marine schemes: Approved participants in ACRES. The Department of Agriculture Food and the Marine have confirmed those awaiting confirmation on their ACRES application can apply pending approval.

Participants in EIP (European Innovation Partnership) Calls 1, 2 and 3, Hen Harrier and Pearl Mussel Projects and The Burren Programme who were an active participant as of 31st December 2022 or had completed the full term of the contract for the relevant EIP, or have completed a five-year contract, as appropriate.

Approved participants of the Organic Farming Scheme.

What works are funded under this scheme

The grant supports

the conservation of traditional farm outbuildings, including roofs, walls, structural repairs, windows, and doors.

the repair of *other traditional farming structures such as walls, gate pillars and gates, walled orchards, cobbled yards and masonry dungsteads.

*You do not have to apply for a building. In 2025, the Heritage Council particularly encourage applications for the repair of traditional farming structures other than buildings. To support this effort, it is intended that €500,000 be specifically allocated this year for the repair of these other related farm structures.

Editor and Project Manager, Superintendent Damian Flanagan, said he hoped the workbook would generate an interest in history and in the Irish language among schoolchildren. He praised the Joint Editor and Project Manager, Marie Mannion, Heritage Officer with Galway County Council.

Ms Mannion said they had worked closely with teachers to ensure the workbook meets the standards for 5th and 6th Class pupils and aligns with the curriculum.

"The whole idea for this is for pupils to understand the rich history of AGS in Ireland, where they came from, what they do and what it means to all of our lives," she said, thanking the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media for funding the project.

Councillor Martina Kinane, Cathaoirleach of the County of Galway said: "This bilingual workbook not only traces the rich history of An Garda Síochána but also highlights the invaluable work they do in our communities. This resource aims to empower you with knowledge and appreciation for our national police service, fostering a deeper understanding of its role in maintaining safety and justice. "As you know, the Garda Síochána plays a crucial role in keeping our communities safe and secure. This workbook is an opportunity for you to discover more about their work in a fun and engaging way. 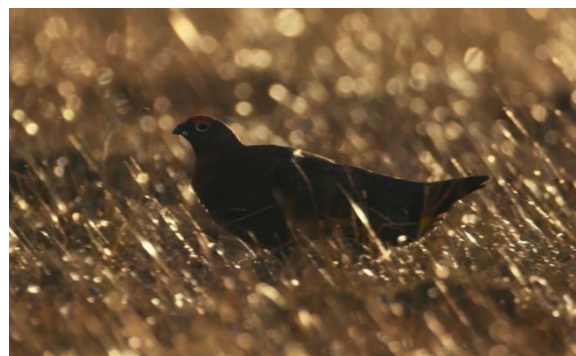
Protection wetlands for our common future requires collaboration and with that in



BALLINASLOE MUNICIPAL DISTRICT UPDATE

During January 2025, the Draft Annual Roads Programme and Multi-Annual Restoration Improvement Grant (RIG) Programme (2025-2027) was presented to the elected members at the MD Monthly meeting and agreed in principle. During the first two weeks of 2025, MD crews were focused on maintenance of public roads in terms of drainage, pothole repair, signage repair, hedge and verge cutting, and minor improvement works. This also include a period of low temperatures where extensive salting operation were required. Separately, crews in Ballinasloe MD were involved with the preparatory work in storage and distribution of the poles and signage for the local road speed limit reduction plan.

Ballinasloe Cycling Club held the Cyclocross National Championships at the Fair Green in Ballinasloe. Assistance was provided by Ballinasloe crews in the setup for the event, which was ran off very successfully.

In the later weeks of January, roads crews have been primarily dealing the preparation for, and the aftermath cleanup following Storm Éowyn. Crews were tasked with immediate emergency works where blocked roads required clearance and have been assisted by specialist contractors where required. The scale of the damage caused, and extents of repairs required is still being measured.

CONAMARA MUNICIPAL DISTRICT UPDATE

In early January the Conamara MD focused on road maintenance works. Priorities included road drainage works such as opening water tables, cleaning gullies and upsizing culverts where there were capacity issues. Other maintenance works include hedge trimming, gritting roads during prolonged winter weather, sign maintenance. On the 24th January 2025 the Conamara MD was hit by Storm Éowyn. This resulted in several road closures due to fallen trees, Eir and ESB poles and cables falling across roads. The Conamara MD outdoor staff are dealing with the aftermath with the clean-up expected to last well into March.

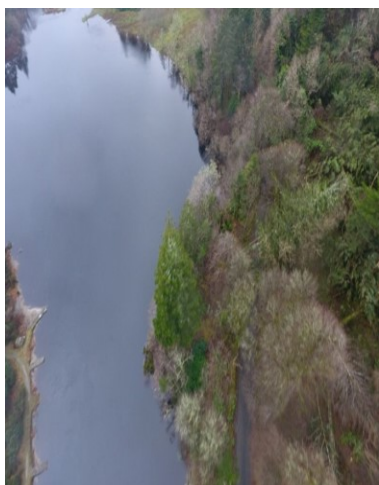

PRIMARY FOCUS OF ACTIVITY

The last few weeks have been devoted almost entirely to preparation in advance of Storm Éowyn and, unfortunately, repair and clean-up in the aftermath of the devastation that was

wrought by this historic weather event. The time allocated to preparing for this event was time well spent with crews being well positioned to address the National and Regional Road network almost immediately on the passing of the red wind warning. Within days, the local road network was also passable. The Gort, Loughrea and Portumna Area Office staff and outdoor crew have done fantastic work over the last two weeks, but the clean-up efforts will continue for some time to come, as the full scale of the damage caused to our public parks, roads, rivers, bridges, public lighting, traffic control systems etc. slowly become apparent. Examples of the damage caused, and significant work undertaken is evident in the photographs below.

As previously noted, the 2025 Roads Programme and Multi-Annual Restoration Improvement Grant (RIG) Programme (2025-2027) was presented to the elected members in January and agreed in principle.

Early start roads have been identified and works have already commenced where appropriate.

We are awaiting confirmation of Regional and Local Road Grant Allocations later this year and any changes required at that point will be incorporated within the current 2025 Road Programme.

A high-level overview of the 2025 Programme is as follows:

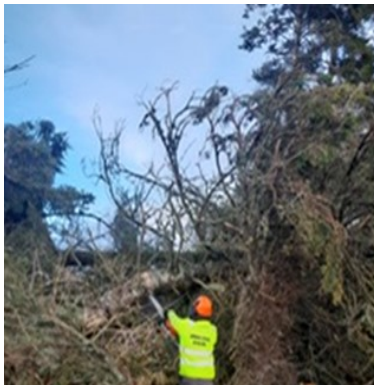
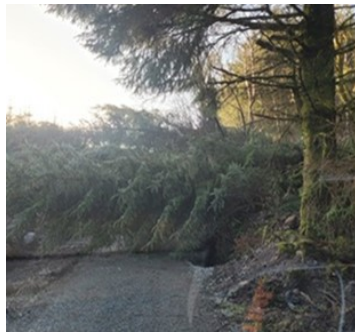
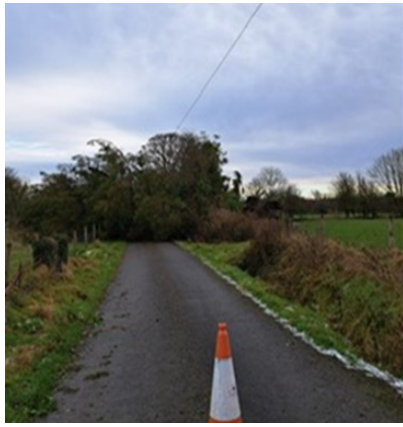

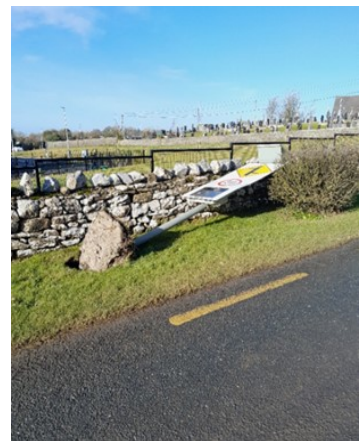

STORM EOWYN

Storm Eowyn was an extremely powerful and record-breaking extratropical cyclone which hit Ireland, on 24 January 2025 and Norway on the night of 24 January into 25 January 2025. It was the 5th storm of the 2024–25 windstorm season

Widespread red weather warnings were issued across Ireland ahead of the rapidly strengthening storm. It was the most powerful and severe to hit Ireland since Hurricane Debbie in 1961 with wind records breaking an 80-year-old record for the country.

By 9am on 25th January most of the Tuam MD district was suffering from power and communication outages and most roads blocked by fallen trees, poles and debris on an unprecedented scale. Significant damage was caused to many properties around the district. By the time the last red weather warning for Storm Éowyn had been lifted on 24 January our roads crews along with technical staff commenced the clean-up operation and gather information on the scope of the widescale damage. Tuam MD had up to 60 personnel in operation during the cleanup over the following 2 weeks including direct labour staff, technical and administration staff and contractors. Upwards of over 2000 fallen trees, poles and debris sites were estimated across the MD.

The cleanup operation was based on a priority measure with the national routes, important infrastructure routes cleared and opened by the evening of Friday 25th. Regional road operations commenced on Saturday 26th which took up to 5 days to complete. Local roads were cleared during the first 5 days. Utility companies including the ESB and Eir worked alongside the roads crews to remove downed lines and poles in order to get the roads reopened.

Clean-up efforts continued into the first two weeks in February with crews removing weakened trees along all routes, removal of debris and fallen trees at the edges of roads. There was significant loss of trees in the Palace Grounds in Tuam with over 120 trees fallen. Contractors are to commence operations in the park in the 3rd week of February.
