<u>Polasaí Rochtana</u> - Is é atá i mpolasaí rochtana Sheirbhís Chartlainne Chontae na Gaillimhe ná an oiread rochtana agus is féidir a bheith ag úsáideoirí bona fide ar a cuid bailiúcháin i gcomhréir le riachtanais maidir le caomhnú ábhair agus i gcomhréir le srianta praiticiúla ar a cuid acmhainní. - Ní féidir le daoine aonair ábhar cartlainne a fháil ar iasacht. Déanfar rochtain ar an gcartlann a sholáthar i gcomhar le rannóg Staidéir Áitiúil Leabharlainne Chontae na Gaillimhe, Teach an Oileáin, Cearnóg na hArdeaglaise, Gaillimh. - Forchoimeádann Seirbhís Chartlainne Chontae na Gaillimhe an ceart chun rochtana ar a bailiúcháin a dhiúltú. - Iarrtar ar gach úsáideoir clárú leis an tSeirbhís Chartlainne agus foirm maidir le hiarratas ar ábhar cartlainne a chomhlánú. - Ní mór cead i scríbhinn a lorg ó Chomhairle Chontae na Gaillimhe/ón gCartlannaí sula ndéantar ábhar de chuid na seirbhíse cartlainne a fhoilsiú. Ach, ós rud é go raibh roinnt bailiúcháin ar fáil d'úsáideoirí Leabharlainne roimhe seo beidh siad ar fáil fós ach sin ag brath ar an riocht ina bhfuil siad. - Ar leith ó na riachtanais atá ann maidir le caomhnú agus bainistiú na mbailiúcháin sula gcuirtear ar fáil iad, d'fhéadfadh sé nach mbeidh rochtain orthu mar gheall ar shrianta eile. D'fhéadfadh sé gur srianta de chineál dlíthiúil a bheadh i gceist mar thoradh ar fhorálacha an dlí a bhaineann le cóipcheart nó d'fhéadfadh srianta a bheith ann de bharr coinníollacha atá leagtha síos ag bhronntóirí; nó d'fhéadfadh srianta prairiciúla a bheith ann mar gheall ar an ngá leis na hábhair a chaomhnú agus a choimirciú nó mar gheall ar shrianta foirne.	<u>Access Policy</u> - The access policy of Galway County Archives Service is to make its collections as accessible to bona fide users as possible, consistent with the preservation of material and the practical limitations on its resources. - Archival material may not be borrowed by individuals. Access to the archives will be provided in conjunction with the Local Studies section of Galway County Libraries, Island House, Cathedral Square, Galway. - Galway County Archives Service reserves the right to refuse access to its collections. - All users are asked to register with the Archives Service, and complete an archive request form. - Written permission must be sought from the Galway County Council / Archivist prior to publication of material from the archives service. Any such publication must acknowledge its source. - In some instances, due to the private or personally sensitive nature of the information in some records, users may be requested to sign a Disclosure Form undertaking not to seek a copy of, take note of, publish or cite in any way named individuals. - It is a policy of the Archives Service that only processed collections, that is collections that have been appropriately cleaned, arranged and described, shall be accessible to users. However, given that several collections have been available to Library users in the past they shall remain accessible depending on their physical condition. - Apart from the preservation and management requirements imposed on collections prior to being accessible other restrictions may also prevent access. These restrictions may be legal, arising from the provision of copyright law or from conditions laid down by donors; or practical, arising from the need to preserve and safeguard the materials or due to staffing limitations.

Data Protection Note to Individuals who are Galway County Council Archive Users.

Galway County Council Archives' legal basis for processing data is attained under Local Government Act, 2001, Section 80 (2), which sets out '*...it is a function of a local authority to make arrangements for the proper management, custody, care and conservation of local records and local archives and for inspection by the public of local archives.*'

Where applicable, Galway County Council Archives may collect and retain all or some of the following personal/business data in relation to individuals who engage with the service:

1. Name
2. Address
3. Contact details i.e.; email address, telephone numbers, fax numbers
4. Nature /title of / research
5. College /Organisation Affiliation
6. Supervisor's name & title
7. Purpose of reproductions (of material from the archives).

This information is collected and retained on Individuals that engage with the Archive Service for administrative purposes, and to assist with safe guarding the physical and moral protection of the archives. It is also used for statistical and informational purposes.

This information may also be shared with the Galway County Council's Galway Public Libraries to assist with / facilitate research queries.

Under section 4 of the Data Protection Acts, 1988 and 2003, and under the Data Protection Act 2018 individuals have a right to obtain from Galway County Council a copy of any information relating to them held on computer or manual filing system.
