Galway County Council redoubles its efforts to enforce the Derelict Sites Register, by identifying more derelict sites, adding them to the register and collecting levies owed. Currently there are only three properties on the County's register - this is not an accurate reflection of the situation on the ground across the County. Properly enforcing the register and collecting levies will discourage dereliction and can raise much needed revenue for the Council to tackle dereliction in our communities.
