1. Minutes of the meeting of the 20th of Feb 2025

• The minutes of the Housing SPC meeting held on the 20th of Feb were proposed by Cllr. Shaun Cunniffe and seconded by Cllr. Declan Kelly and agreed.

Safe Home Ireland –

Mr. Ger Scully gave a presentation to the committee that discussed the background to the Safe Home Ireland initiative and Cllr. Evelyn Parsons proposed amendment to the Housing Allocation Scheme 2024 (HAS). He outlined in detail the existing number of Local Authority and Approved Housing Body (AHB) 1 & 2 bedroomed units that are currently available to Galway County Council's Housing Support Applicants. A copy of Cllr. Parsons proposed Notice of Motion submission to Amend the Housing Allocation Scheme – Inclusion of Safe Home Ireland and Returning Irish-Born Emigrants under Sections 1.4 and 4.1 was provided to the members in advance of the meeting taking place.

- Mr. Scully outlined and explained Cllr. Parsons proposed Notice of Motion submission to Amend the Housing Allocation Scheme (HAS) to include Safe Home Ireland and Returning Irish-Born Emigrants as a distinct category type under Clause 1.4 & Section 4.1 of the current HAS 2024.
- Mr. Scully stated that the Tenant in Situ (TIS) scheme that was introduced in April 2023 was not added to GCC's Housing Allocation Scheme as a specific Allocation Category until May 2024 and yet TIS dwellings were successfully acquired and allocated to the sitting tenants under provision (k) of Clause 1.4 and item (xii) of Section 4.1 which reads as follows, Any projects or initiatives for whom the council in its discretion considers it prudent to provide accommodation.
- He stated that Clir. Parsons original motion would have required specific Older Persons Dwellings being set aside for returning Safe Home Ireland Applicants. He stated that this would have resulted in certain OAP applicants being bypassed for allocation by a returning Safe Home Ireland applicant.
- A submission from Cllr. Geraldine Donohue was emailed to the members before the meeting, and it was also read out and discussed at the meeting.

The Chair thanked Mr. Scully for his presentation, and he pointed out that Cllr. Parsons initial Safe Homes Ireland Motion to amend the Housing Allocation Scheme for returning emigres would have resulted in Safe Home applicants jumping to the top of the Housing Waiting list within each MD and housing units being set-aside for them. The chair stated that he had major issues with older persons being jumped on the list and he was not in favor of Safe Home Ireland applicants been added as special category.

Mr. Damien Mitchell (Director of Service - Housing) thanked Mr. Scully for his presentation and acknowledged that the proposal before the committee for discussion and approval was complicated. He outlined that Safe Home Ireland Applicants are already catered for under Clause 1.4 (k) and Section 4.1 (xii) of the existing Housing Allocation Scheme 2024. As per Cllr. Parsons Notice of Motion that went before the April 2025 Plenary

Council Meeting, he confirmed that if suitable Older Person Dwellings were set aside for returning applicants, then this would raise the priority status for these applicants. This would also require the setting aside of seven suitable OPD dwellings and in some instances, they may be left unoccupied due to the absence of a suitable Safe Home Ireland applicant in that MD. He concluded by saying that the adoption of the above amended proposal at plenary would not afford priority status to Safe Home Ireland applicants, but rather they would qualify for an allocation in the same manner as all other eligible older person applicants and no LA owned Dwellings will be set aside.

Cllr. Gerry Finnerty agreed with the Chair and the Director that Safe Home Ireland Applicants are already catered for under the existing provisions as set out under clause 1.4 and Section 4.1 respectively and he supported the current motion before the committee.

Cllr. Sean Cunniffe sought clarity as to the approximate number of safe home Ireland applicants that return to Co. Galway each year, and he suggested that specific wording could be included to allocate an unfilled Safe Home Ireland dwelling to the next OAP applicant from the HWL.

In response, Mr. Mitchell reaffirmed that Safe Homes Ireland Applicants are already being allocated suitable LA properties under Section 1.4 and Clause 4.1 of the HAS 2024 based on their individual needs and length of time on the HWL.

Cllr. Shaun Cunniffe, followed up by saying that due to the circumstances that forced these people to leave Ireland, he said that he would like to have some special priority or credit be assigned for these Irish citizens that now wish to return home and seek social housing supports. He stated that he was not in favor of leaving housing units vacant due to the lack of a suitable Safe Home Ireland Applicant.

Cllr. Jimmy McClearn thanked both Mr. Scully and Mr. Mitchell for providing some clarity on the specifics of the proposed amendment, and he said that it was important that returning emigrees should have the opportunity to apply for housing supports in their original home areas. He said that the contributions from both Mr. Scully and Mr. Mitchell had brought clarity to the proposal before the committee and he was in favor of the current motion before the committee.

Mr. Scully confirmed that there was no issue regarding qualification for Housing Supports as most Safe Home Ireland applicants qualify under the existing scheme of allocation priorities that relate to persons in the OAP category.

Cllr. Declan Kelly said that he concurred with Cllr. McClearn regarding the importance of having a mechanism that allowed Irish emigrates to return home to their communities and seek Housing Supports. He stated that he was in favor of increasing the amount of OPD Housing units and that he was in favor of the proposed amendment.

Cllr. Eileen Mannion said that she was not in favor of the original proposal that would have resulted in specific Housing Units being set aside for returning applicants, and she said that Mr. Scully and Mr. Mitchells comments had explained clearly that these Safe

Home Ireland applicants were adequately catered for under the existing HAS provisions as outlined in Clause 1.4 and Section 4.1 of the HAS 2024.

The Chair, **Clir. Mahar** asked that Mr. Mitchell read aloud the comments of Mr. Michael Owens from the SPC minutes of the 20th of Feb 2025 meeting, whereby" he stated that Safe Home Ireland Applicants would continue to be supported under the existing provisions of the current Housing Allocation Scheme, and their duration on the HWL would be the primary determining factor for their allocation". Mr. Mitchell reaffirmed that Safe Home Ireland Applicants would qualify as normal and then be considered for an allocation when a suitable LA property becomes available.

The motion was proposed by Cllr. Eileen Mannion and seconded by Cllr. Gerry Finnerty.

The Chair, concluded by saying that the Safe Home Ireland motion would go back to the July 2025 Plenary Council Meeting for consideration and if approved the motion would be incorporated into the existing Housing Allocation Scheme 2024 under Clause 1.4 and Section 4.1. he added that this would allow returning Irish immigrants living abroad to apply for Social Housing supports from Galway County Council. Mr. Mitchell reiterated that no Local Authority Housing units would be set aside for Safe Home Applicants.

3. Healthy Age Friendly Homes Programme (HAFH) - Update

Ms. Marie Nolan, Administration Officer, give a presentation to the committee members on the Healthy Age Friendly Homes Programme. The following topics were discussed, and a PDF copy of the presentation was emailed to the committee members after the meeting.

The Chair thanked Ms. Nolan and her colleagues for their presentation he opened the topic to the members for any comments and questions they may have.

Cllr. Gerry Finnerty thanked Ms. Nolan and her colleagues for their presentation, and he said that the topic was very close to his heart as he believed that this service helped to keep older persons in their own homes for as long as possible. As public representatives, he stated that Councillors are uniquely placed to encounter older persons who are struggling and require support and services such as those provided by Age Friendly Homes Programme and he very much welcomed and acknowledged the services they provide within County Galway and across the country.

The Chair wished to acknowledge the fantastic work and services that Ms. Nolan and her colleagues Francis and Dónal have been doing across County Galway, and he enquired if there were any changes or issues with funding that are coming down the line for the shared service.

In response, Ms. Nolan outlined that the service was in a unique position to highlight and raise awareness of any current or potential issues that are affecting older persons. She outlined how Age Friendly Homes Ireland has helped to bring community-based services to the residents of Nursing Homes and they have collaborated with the Fire Service to carry out home fire safety visits. Ms. Nolan said that it is intended to upscale this collaboration with the Fire Service so as it can be extended and rolled out nationally. It is hoped that Age Friendly Homes Co-Ordinator's can directly refer clients to the Fire Service for a Fire Safety assessment. In 2024, she said that there was a lot of calls regarding the changes to the Housing Adaptation Grant whereby the installation of new boilers was no longer covered under the scheme. Ms. Nolan said that they are there to help older persons in need, but she stressed that they do not lobby. She concluded by saying that here is a misconception that persons who own their own house are wealthy, however it often disqualifies them from accessing services and the dwelling may not be very habitable.

- Clir. Shaun Cunniffe thanked Ms. Nolan for her presentation and for the amazing work that was being carried out daily by the staff of Age Friendly Homes. In Reference to the case study discussed in the presentation. He said that information was power and once people had access to it, they can begin to address their issues, and he commended the service for their hard work.
- Mr. Dónal Clancy (Coordinator) explained that he himself had helped the couple that were mentioned in the presentation case study, and he explained that his work was challenging but very rewarding.
- Mr. Francis Kane said that coordinators can visit clients in their own homes as many times as is required and it was his experience that many of the people, they encounter are often not proficient or comfortable with using the internet for information and services. He stated that his role was highly rewarding, and it was great to be able to help older people in this manner.
- Ms. Nuala Heffernan said that it had been a very positive experience working with both Donal and Francis, and she outlined that there were significant daily interactions between both coordinators and the Housing Grant Application and Inspectorate teams.

Ms. Marie Nolan thanked Ms. Heffernan for her comments, and she stated that NAFH was only as successful as the collaborations they make with organizations that they work with, and this is why it is important to have a close working relationship with organizations like GCC's Housing Department.

4. Galway County Council's Draft Homeless Action Plan 2025 – 2027

Ms. Nuala Heffernan gave an update presentation on the Homeless Action Plan to the committee members. The following topics were discussed, and a PDF copy of the presentation was emailed to the committee members after the meeting.

The **Chair** thanked Ms. Heffernan for her informative presentation, and he welcomed the ambitious future-plans for Homeless Services that are planned for the second half of 2025 and in 2026. He praised the Homeless Services and Housing First policies that were outlined in the presentation, and he hoped that these ambitious plans can be implemented.

Mr. Mitchell commended and thanked Ms. Heffernan for all her work in the Homeless Services area and he said that she regularly goes above and beyond when it come to the implementation and provision of GCC's Homeless Services.

Clir. Mannion thanked Ms. Heffernan for her presentation, and she stated that she is regularly contacted by working people and families who have bene issued with a notice to quit (NTQ) and can't find a property to rent and they do not qualify for social housing. She stated that an emergency should be called to help these working people who cannot find suitable rental properties or get on the property ladder.

Ms. Heffernan thanked the members for their comments and ongoing support.

5. Planned Housing Maintenance – Update

Mr. Daithi Flood presented an update on Planned Housing Maintenance to the committee. The following areas were discussed, and a PDF copy of the presentation was emailed to the committee members after the meeting.

The **Chair** thanked Mr. Flood for his detailed presentation, and he congratulated him and his staff for their work on returning voids and derelict units fit for new tenants. He stated that rents is a major issue for some constituents, whereby tenants are required to inform the council of any changes to their circumstances, and this is preventing people from purchasing their properties under the Tenant Purchase scheme due to arrears on their rent account.

In reply to a query from Cllr. Cunniffe, **Mr. Ger Scully** stated from a Tenant and Estate Management (TEM) point of view, the Housing Liaison Officers (HLO) are actively involved in each of their respective housing, and he outlined how a 'boots on the ground' campaign was introduced in 2024 to target specific estates in each Municipal District where issues had been identified. This involved Community Wardens, Dog Wardens, TEM and HLO staff going door to door in each estate to discuss any issues with active tenants. He said that 7 estates were visited last year, and they intend to visit 11 estates in 2025 and 20 estates in 2026.

Mr. Flood said that the Housing maintenance teams work closely in collaboration with the TEM and HLO staff to ensure that any unplanned maintenance repairs/works are sustainable so that they do not have to return to the property again and again to carry out the same repair works. He said this this helps to ensure that value for money is attained on any planned or unplanned repairs that are carried out.

Cllr. Mannion thanked Mr. Flood for his presentation, and she welcomed the support given to tenants in the boots on the ground campaign as mentioned by Mr. Scully.

In reply to a query from Rachel Stuart, Mr. Mitchell outlined that the Plenary Council have approved a borrowing facility for €10 million euros for GCC's Planned Maintenance programme. He stated that this finance facility will be available to GCC once the relevant surveys have been concluded, as the extent of the required planned maintenance works are identified.

6. Any Other Business

Future Housing SPC Meeting dates

The Chair confirmed that the two remaining Housing SPC meetings will occur on the 25th of September and the 18th of December 2025 at 11am in the Council Chamber.

Anti-Social Behavior in Glenamaddy

Clir. Peter Keaveney wished to inform the committee about reports of anti-social behaviour that is ongoing in Glenamaddy. He stated that a local businessman has taken in approximately 10-12 housing clients from both Mayo and Roscommon County Council's, and he outlined that there is no 24hour back up service to supports these people who have complex needs. He outlined that there have been instances of anti-social behaviour by the residents and the building has been visited on a regular basis by both An Garda Siochana and the Ambulance Service. He also outlined that he has discussed the issue with Director Mitchell, and he wanted to bring it to the attention of the Housing SPC Committee.

In response, Mr. Mitchell outlined that a plan is now in place to resolve the issue in Glenamaddy, whereby both Mayo and Roscommon councils have committed to remove the individuals from the site. He explained that the property in question has been referred to GCC's Planning Enforcement section to check if the appropriate planning permissions are in place.

Derelict LA units

In response to a query from **Clir. Declan Kelly**, Mr. Mitchell outlined that the refurbishment and reoccupation of a derelict LA housing unit would depend on the cost of the works required to bring the building up to current building regulation standards. He stated that since the introduction of the Voids Programme in 2014, Local Authorities can only claim back €11,000 in refurbishments costs. Therefore, Housing must assess the properties' location, the urgency of the applicants housing need and the costs associated with the schedule of works that are required to bring the property back into circulation.

Ballymoe Village

In response to a query from **Clir. Peter Keavney**, Mr. Mitchell confirmed that the keys for the new Ballymoe Village units were received from the builder today and the delay was due to issues with the onsite ESB connection. He stated that these units will be allocated to tenants in the coming weeks.

Vote Of Sympathy

On behalf of the committee members a resolution of sympathy was extended to the outgoing Director of Service for Housing Mr. Michael Owens & the extended Owens family of Castlegar, Mountbellew, Ballinasloe, Co. Galway.

Cllr. Eileen Mannion offered her sincere condolences to Michael Owens and his family following the sudden passing of his late mother Mary. She also wished to thank him for all his help and support during his tenure as the Director of Service for Housing and she wished him well in his new position. Cllr. Mannion welcomed Mr. Mitchell as the incoming Director of Service for Housing.

Mr. Mitchell thanked Cllr. Mannion for her kind words of welcome and he acknowledged the phenomenal contribution made by Mr. Owens during his tenure as the Director of Service for Housing. He pointed to Mr. Owens work ethic and attention to detail, and he wished him well for the future in his new role.

The Chair thanked all present and online for their participation and he confirmed that the next Housing SPC meeting is scheduled for 11am on the 25th of September 2025. The meeting concluded.
