

Galway County Council plan to acquire lands at Carrowmanagh Park by CPO for the purpose of compensatory planting of approximately forty trees, to offset tree felling outside of Carrowmanagh Park as part of the Oughterard Footbridge project.

There is also a plan to install an access gate from the Carrowmanagh Park Green to the Owenriff Riverwalk.

While the residents have no objection to the footbridge, we do object to the excessive number of trees that are planned to be planted on the open green area of Carrowmanagh Park, which will take away a large portion of the open amenity space which has been part of the estate since its creation in the year 2000.

This open amenity space is used a play-area by the resident children. The number and density of planned trees will take away much of the open playing space and will cause other problems such as road safety and visibility issues for motorists driving adjacent to the open area.

Although it may be desirable and convenient for Galway County Council to plant new trees as close to the felled trees as possible, there is no legal obligation to plant new trees within a certain distance of felled trees, and the required minimum distance between felled trees and new trees is not defined in the planning application. Furthermore, most of the trees that are planned to be felled are on the south bank of the Owenriff river, while the green area of Carrowmanagh Park is on the north bank. Surely it makes sense to plant new trees on the same side of the river as the felled trees? Compensatory planting at other locations along the Owenriff riverbank, and in other areas of Oughterard should be investigated.

The boundary wall between Carrowmanagh Park and the Owenriff riverwalk is in a bad state of repair and sections have previously collapsed. Planting a large amount of trees close to the wall has the potential to destabilise the foundations of the already dangerous wall.


Fig.1: Crossing Carrowmanagh Park Roadway from green area with no visibility of oncoming traffic.

Addition of an access gate on the boundary wall has the potential to create a shortcut through Carrowmanagh Park which could be used by children attending the nearby national and secondary schools. If crossing the gate from the riverwalk into Carrowmanagh Park on the way back to school, children would immediately encounter a blind corner with no footpath, and no visibility of oncoming traffic when crossing the roadway of Carrowmanagh Park (Fig.1). This represents an unacceptable and unnecessary hazard.




While I have no objection to the footbridge, I do object to the excessive number of trees that are planned to be planted on the open green area of Carrowmanagh Park, and where they are to be planted.

- (i) no objections are received by the Commission within the period provided for making objections, or
- (ii) all objections made are subsequently withdrawn, or
- (iii) all objections made relate exclusively to matters which can be dealt with by a property arbitrator the Commission will inform the local authority as appropriate and, in such circumstances, the local authority can itself confirm the order with or without modification or refuse to confirm the order in accordance with the provisions of section 216 of the Planning and Development Act, 2000, as amended.

The Commission has absolute discretion to hold an oral hearing in respect of any application before it, in accordance with section 218 of the Planning and Development Act 2000, as amended. Accordingly, the Commission will inform you on this matter in due course.

Upon review of Compulsory Purchase Order (No. 3) 2025 N59 Oughterard Footbridge by Galway County Council, I am presenting objections to Compulsory Purchase Order (No. 3) 2025 on the basis of the following findings.

Galway County Council plan to acquire lands at Carrowmanagh Park by CPO for the purpose of compensatory planting of approximately forty trees, to offset tree felling outside of Carrowmanagh Park as part of the Oughterard Footbridge project.

There is also a plan to install an access gate from the Carrowmanagh Park Green to the Owenriff Riverwalk.

Along with other residents I have no objection to the footbridge, but do object to the excessive number of trees that are planned to be planted on the open green area of Carrowmanagh Park, which will take away a large portion of the open amenity space which has been part of the estate since its creation in the year 2000.

This open amenity space is used a play-area by the resident children. The number and density of planned trees will take away much of the open playing space and will cause other problems such as road safety and visibility issues for motorists driving adjacent to the open area.

Although it may be desirable and convenient for Galway County Council to plant new trees as close to the felled trees as possible, there is no legal obligation to plant new trees within a certain distance of felled trees, and the required minimum distance between felled trees and new trees is not defined in the planning application. Furthermore, most of the trees that are planned to be felled are on the south bank of the Owenriff river, while

the green area of Carrowmanagh Park is on the north bank. Surely it makes sense to plant new trees on the same side of the river as the felled trees? Compensatory planting at other locations along the Owenriff riverbank, and in other areas of Oughterard should be investigated.

I understand sections of the boundary wall between Carrowmanagh Park and the Owenriff riverwalk have previously collapsed. Planting a large number of trees close to this wall has the potential to cause further damage and instability

Addition of an access gate on the boundary wall has the potential to create a shortcut through Carrowmanagh Park which could be used by children attending the nearby national and secondary schools. If crossing the gate from the riverwalk into Carrowmanagh Park on the way back to school, children would immediately encounter a blind corner with no footpath, and no visibility of oncoming traffic when crossing the roadway of Carrowmanagh Park (Fig.1). This represents an unacceptable and unnecessary hazard.



Fig.1: Crossing Carrowmanagh Park Roadway from green area with no visibility of oncoming traffic.

Young children playing on the open green area would inevitably be attracted to the gate and potentially gain access to the riverwalk and associated danger of the fast-moving Owenriff river.
