10. Cllr. Joe Sheridan

I will propose:

"I propose that Galway Co. Co. pay 'Red Alert' standby rates to our Fire brigade 1st responders staff to be 'ready to go' upon need in rare but more frequent red alert periods."

11. Cllr. Alastair McKinistry

I will propose:

That Galway County Council will update and review the Disability Action Plan 2007-2015, taking regard for updates in National policy and legislation, and produce a new Action Plan on inclusion and disability services. The new action plan should be a live document and be aligned with the National Action Plan for Disability Services 2024-2026.

12. Cllr. Dr. Evelyn Parsons

I will propose:

I propose that GCC collaborate with the Health Services Executive as a matter of urgency in relation to adequate provision of accommodation for Healthcare Staff and their Families who are engaged in providing essential clinical and healthcare services in Portlincula University Hospital and in nursing homes and home care services.

Ensuring adequate accommodation for essential healthcare staff and their families is crucial for the efficient functioning of healthcare services & the shortage of suitable accommodation poses a significant challenge in attracting and retaining essential healthcare professionals, particularly those from overseas on whom we significantly depend to staff our hospital and nursing homes and care roles.

The local authority has a responsibility to support and collaborate with health services to address this pressing issue. The importance of PUH to the county is contained in the GCDP.

I propose that GCC collaborates with Health Services Executive to ensure there is adequate accommodation available for essential healthcare staff and their families to facilitate the filling of essential posts, that it works closely with health services to identify suitable housing options, including rental properties, affordable housing developments, and temporary accommodations, to meet the needs of healthcare professionals;

including exploring potential partnerships with local housing agencies, landlords, and developers to expand the availability of housing options for essential healthcare staff and their families.

The accommodation lack is such that the establishment of a dedicated task force or committee comprised of representatives from the local authority, health services, housing agencies, and relevant stakeholders is urged to develop and implement strategies to address the accommodation needs of essential healthcare staff and their families and that GCC and HSE work on allocating necessary resources, including funding and staff support, to implement and monitor the effectiveness of the initiatives aimed at providing accommodation for essential healthcare staff and their families, and make adjustments to the accommodation strategies as needed.

13. Cllr. Shane Curley

I will propose:

This Council actively supports the Boycott Divestment Sanctions campaign and commits to changing procurement policies by not purchasing goods or services, produced or provided, in whole or in part, (as practicable), from Israeli settlements in Occupied Palestinian Territory, and that any such contracts should cease as soon as allowed.

This Council calls for the enactment of the Control of Economic Activity (Occupied Territories) Bill (2018) as a matter of urgency.
