22. Cllr. Herterich Quinn & Cllr. Kinane

We will propose:

“When it comes to addressing gender balance on external boards like the GRET, GRD, and NWRA, that the membership of Galway County Council is conscious of the necessity for gender balance to support the delivery of stronger outcomes for individuals, organisations, and communities, and in particular where a Statutory Instrument exists.

Where no Statutory Instrument exists for external boards, that we as the Elected Representatives for our County work together to ensure that a Statutory Instrument is put in place for gender balance.”

23. Cllr. Curley

I will propose:

“That Galway County Council supports the campaign of Epilepsy Ireland to address long-standing issues that continue to impact on people with epilepsy and their families in Ireland today, namely:

1. Access to Free Travel.

2. Provision of Reasonable Accommodations for State Examinations for students with epilepsy.” The Motion, if agreed, to be then sent to the Minister for Health, Stephen Donnelly TD, Minister for State for Disabilities, Anne Rabbitte, T.D. Minister for Social Protection, Heather Humphreys TD, Minister for Education, Norma Foley TD, Michael Moynihan TD (Chair, Oireachtas Committee on Disability Matters) and to other local authorities for correspondence purposes.”

I will propose:

“That this Council propose to the Minister with responsibility for Inland Fisheries Ireland, the CEO of Inland Fisheries and Bord Failte that the current necessity for a permit to fish the River Suck be withdrawn”.

“That Galway County Council write to both Chairpersons of A.I.L.G. and LAMA, Director of NWRA and Minister for Local Government Darragh O’Brien, seeking that a process commences to explore mechanisms or policy recommendations that can be put in place by June 2024 to ensure a more inclusive Regional Assembly.”

“This Council notes that in the 'Connecting Ireland' proposals for County Galway, the NTA incorrectly reference a service to Eanach Dhúin/Annaghdown in Proposal 22A, which stop/service as outlined therein is actually 10.67km as the crow flies from the village of Annaghdown, while Proposal 21 also lists a service to Corrandulla despite omitting the village of Corrandulla entirely, and calls on the NTA to immediately rectify and amend their proposals.

This Council further calls on the NTA to revise the entirety of its plans under Proposals 21 and 22A of 'Connecting Ireland' to provide a proper rural public transport option which directly services the villages and environs of Annaghdown, Corrandulla, Caherlistrane, Auchlogheen, Bawnmore, Kiloughter and Menlo, all of which have been omitted from same.

The Council will send this proposal to the NTA and Minister for Transport on approval.”

29. Cllr. Cuddy

I will propose:

“that in view of the failure of the Department of Finance to provide sufficient funding to Galway Council to provide a proper level of services within the County of Galway that a letter signed by all the elected members outlining the shortfall be sent immediately to each of the Oireachtas members for the county of Galway and the Minister for Finance and Public Expenditure to deal with this issue before the Budget Plenary meeting takes place at the end of the month.”
