**I will propose:**

Part 1) This Council calls on the Irish government to ratify, without further delay, The Council of Europe Convention against Trafficking in Human Organs which was adopted by the Council of Europe on 9 July 2014 in order to criminalise illegal organ transplantations. The Irish Government has already signed this convention, but is yet to ratify it.

Part 2) This Council calls on the Irish Government, as a matter of urgency to emphatically demand the Chinese Government to immediately cease the persecution and Forced Live Organ Extraction of peaceful Falun Gong practitioners and release all Falun Gong practitioners and other prisoners of conscience from incarceration and captivity.
