**ITEM NO. 1 CONFIRMATION OF MINUTES OF THE FOLLOWING MEETING**

(a) Minutes of Monthly Plenary Meeting held on 17<sup>th</sup> September 2021.

On the **PROPOSAL** of Cllr. Cuddy **SECONDED** by Cllr. Curley the Minutes of the Monthly Plenary Meeting held on the 17<sup>th</sup> September 2021 were **AGREED** subject to the following clarification by Cllr. Mannion that that not every member of the Connemara Municipal District had voted against a planning application for social housing in Moycullen.

Cllr. King welcomed the extension of lifeguard working hours during the Summer and asked that the extended hours be considered for next year. In response, the Chief Executive advised that the matter would have to be considered in the context of available funding in the Budget.

Clarification was sought on the completion date for the Town and Village Streetscape Scheme. In response Mr. Hanrahan confirmed that the deadline for submission of applications was extended to 31<sup>st</sup> December 2021. He also confirmed that all funds must be drawn down by the groups by May 2022.

**ITEM NO. 8 TO CONSIDER THE MANAGEMENT REPORT – OCTOBER 2021 IN ACCORDANCE WITH SECTION 136 (2) OF THE LOCAL GOVERNMENT ACT 2001 (AS AMENDED)** **3847**

**Matters arising:**

**The following points were raised by Cllrs. Byrne, Hoade, Parsons, Charity, Cuddy, Mannion, Ó Cualáin, Mac An Iomaire, McKinstry, Maher, McClearn, Broderick, Kinane, Geraghty, Roche, Carroll, Killilea, Collins,**

- The max HAP allowance is only €690, this must be revised by Central Government.
- The shortage of staff in the Housing Unit.
- The issue of security of County Buildings at night time.
- The changes made in the Area of Choice of Athenry/Baile Chláir /Oranmore for Housing Applications clients.

- The current status of works on the N84 were queried. An update on the N84 Safety inspection was also requested.
- The lack of reference to the N84 in the Management Report was highlighted.
- Decision re Outer Ring Road was now vital for the people of Baile Chláir.
- The announcement of the contract signing for the Moycullen Bypass was welcomed.
- Request was made for a safety inspection report on the N59 between Clifden and Leenaun.
- Concerns were raised about the state of disrepair of the roads in Connemara.
- Concerns were raised that a decision could not be made on the proposed upgrade of the R336 until the fate of the Galway Ring Road was decided
- Focus needs to shift to improving public transport in the county.
- The lack of engineering staff in the Municipal District of Loughrea was raised and the matter needs to be address urgently.
- The lack of staff in the planning enforcement section may undermine proper planning and enforcement procedures across the county.
- Could the prior notice process be reinstated allowing councilors to be informed if an application was going to be unsuccessful?
- Lack of staff comes back to the underfunding of Galway County Council and Central Government needs to attend to this issue urgently.
- Sought clarification on level of vacant properties in Tuam and Loughrea areas.
- Commended the exceptional service offered by lifeguards during the season, noting that there were 64 rescues.
- Update requested on the cycleway between Salthill and Bearn Pier.
- Issue of the vacancy for an engineer in South Connemara and whether the position would be offered to an Irish speaker.

**Members queries were responded to as follows by Mr. Hanrahan:**

- The decision to split the Area of Choice was due to the volume of applications for the Athenry/Baile Chláir /Oranmore area. There are over 900 applications. By splitting the area, it was hoped that they could offer a tighter area of choice to the applicants. Connemara received approximately 100 applications.

- A new member of staff was starting in the Housing department. The housing unit are currently reviewing the housing grants application system. The number of housing grant applications has doubled. 70% of applications are incomplete and must be returned for further information.
- Currently there are 3 vacant properties in Loughrea, one of which had been turned down by 3 different applicants and there are 7 vacant properties in Tuam, 4 of which are undergoing major refurbishment.

**Members queries were responded to as follows by Mr. Pender**

- The Engineering position in the Loughrea has been offered.
- The proposed Cycle-Way between Salthill and Bearna Pier is a joint venture between Galway City and Galway County Councils.

**Members queries were responded to as follows by Mr. Owens**

- The planning enforcement is essential in maintaining the integrity of the Planning Department. A recruitment process is at an advanced stage.
- The “prior notice” practice is resource intensive and would require a Data Protection Impact report. With the current level of staffing in the planning unit it is not a feasible option.

**Members queries were responded to as follows by Ms. Ruane**

- A recruitment plan is in action. 36 additional staff were required, 21 have been recruited and 15 others are at an advanced recruitment stage. The cost of these additional staff in phase one is €2 million. An additional 48 positions are necessary, but these are entirely dependent on funding. An additional €2.5 million is required to fill these posts.
- Regarding the engineering vacancy for in South Connemara fluency in Irish is not currently a requirement in the recruitment process.

The Chief Executive explained that the staffing issue was a basic question of funding and that one could not be discussed without the other. He noted that the chronic baseline underfunding has impacted on the level of service that the organisation can deliver. He pointed out that funding in the region of an extra €20 million was needed.

This existing funding shortfall coupled with the failure to increase LPT will lead to a somewhat difficult 2022 budget. He concluded that with revenue in excess of €130 million a year being spent, Galway County Council are a massive investor in the county. Unfortunately, that is not being acknowledged by or reflected in Government funding of Galway County Council.

Cllr. Donohue raised the issue of the unnecessarily complicated demands placed by Social Welfare on people applying for Carer's allowance.

**ITEM NO. 13. NOTICE OF MOTION**

**3852**

Cllr. Herterich Quinn & Cllr. Kinane submitted the following Notice of Motion:

"When it comes to addressing gender balance on external boards like the GRETb, GRD, and NWRA, that the membership of Galway County Council is conscious of the necessity for gender balance to support the delivery of stronger outcomes for individuals, organisations, and communities, and in particular where a Statutory Instrument exists.

Where no Statutory Instrument exists for external boards, that we as the Elected Representatives for our County work together to ensure that a Statutory Instrument is put in place for gender balance."

Concerns were raised regarding the gender imbalance on the board of the GRETb. A discussion took place and the Chairman of the GRETb, Cllr. Maher, made it clear that the GRETb had strived to achieve gender balance. Cllr. Maher stressed that he supported gender balance. He also noted that GRETb on foot of any vacancies on the Board write to Galway Co Council to ascertain if any female members wish to sit on the GRETb Board. He referenced correspondence he had recently forwarded to Galway Council on the matter and that he awaited a reply.

Cllr McClearn said that the onus was on all political parties to meet the requirement for gender balance.

The Chief Executive confirmed receipt of correspondence from the GRETb and confirmed that all female members of the council had been contacted about filling a vacancy on the board. All had indicated that they did not wish to sit on the Board at this time.

Cllr. Herterich Quinn stressed that she has always had an interest in becoming a member of the GRETb board but had previously been out-voted. She indicated that was making herself available again now. She expressed disappointment that external Councillors were appointed to external interview boards of GRETb.

Cllr. Kinnane confirmed that she had not put her name forward for the most recent GRETb vacancy at that point in time. She expressed concern about appointing a female councillor from another county. She suggested a meeting of the heads of the

political groupings was needed to discuss the matter. She confirmed that she was available for any future positions. She clarified she was referring to the appointment of female Members to "interview boards" of the GRETB

Cllr. Maher assured the members that he wished to rectify the situation and wanted the female councillors to be accommodated. He noted that a person must be a member of the board to be eligible for appointment to an interview board committee. Cllr. Hoade expressed her disappointment that Cllr. Maher had received abuse over the matter noting he was clearly in favour of gender balance. She confirmed she was not interested in the position.

Cllr. Mannion confirmed that she had been given the opportunity to sit on the board but declined it due to work commitments.

This item was deferred to the November Plenary Meeting as the maximum allowed time for the meeting had elapsed.

a major component in the halt to decline bee species, and other pollinators. Wild flowers are essential to the flora and the fauna of our countryside, and provide a natural habitat for many birds, small mammals and insects.

They are also more visually enhancing, providing a relaxing atmosphere for country walks. In a time where mental health has never been as important, I feel that this is a prime factor in this motion.

Wildflowers are also very low maintenance, which means lower costs to our already stretched funding. Once established, they need very little care, with as little as two cuttings a year."

is very clear now that the M 6 has not made any worthwhile reduction to the volume of traffic going through the village of Baile Chláir each day and is now worse than ever.

Galway County Council is in agreement that the relief road should proceed and it is referenced both in the present County Development Plan and the Draft County Development Plan 2022-2028 and lands along the preferred route have been frozen for years. Local people need certainty now in order to be able to plan for the future.”
