ITEM NO.2 CONSIDERATION OF REPORTS AND RECOMMENDATIONS 4104

On the **PROPOSAL** of Cllr. Byrne **SECONDED** by Cllr. Walsh the minutes of the Housing Strategic Policy Committee held on 16th November 2022 were **AGREED**.

In response to queries raised by the members from the minutes, Mr. Owens commented on the following points

- In relation to the definition for 'Substantial Works' in the context of a planning application for extension of duration, the matter was considered by the Planning, Environment, Agriculture, and Emergency Services SPC and with the benefit of a legal opinion it was determined that 'Substantial Works' should not be informed by a rule of thumb but rather on the basis and specific nature of the relevant application/development including the extent of works undertaken/level of expenditure incurred.
- A seminar for planning agents was held in late November 2022 with very positive feedback from attendees. A commitment was given during the CDP process for a similar seminar for Councillors and this would be arranged as staff resources and other commitments allow.

- The OPR will be undertaking a review of the planning function in all local authorities with a number completed to date. Galway County Council will be subject to a review in due course, and it is anticipated that the resourcing of the function and related service delivery standards including statutory obligations will be a significant factor.
- In light of the reduced staff numbers, it will be necessary to prioritise the development management function. This will unfortunately impact the work programmes in other areas within the Planning Unit. It was noted that the Planning Unit will be experiencing a further challenging period in terms of available staff resource, the number and nature of planning applications and work programmes.
- Clarified that any communication by the Members in relation to a planning application within the statutory period for determination of an application or appeal should be in writing only in order that it can be recorded and placed on the public file in order to ensure that the process remains open and fully transparent to all parties with an interest in the relevant application/appeal.
- Pre-planning meetings recommenced in September 2022 and remain available with the option for in-person, conference call or Teams.

- Update on Galway City Ring Road Project

- Galway City Ring Road Project is currently with An Bord Pleanála and they will inform Galway County Council of any additional information they require.
