**CALL FOR RETAINED / PART-TIME FIRE FIGHTERS: GORT FIRE STATION**

- 1) A recruit Firefighter shall be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.
- 2) A recruit Firefighter must have attained a satisfactory level of education to enable them to perform satisfactorily as a Firefighter and to successfully undergo the appropriate training.
- 3) A recruit Firefighter shall possess a valid full current Category B Driving Licence at the time of applying for the post.
- 4) A recruit Firefighter must live and work within a maximum of 8 minutes travel time from the assigned Retained Fire Station, to allow them to respond for the duration of their employment as a Firefighter.
- 5) Firefighters are required to be available and attend alerts 24 weeks in the year on a rostered-on/flexible basis.

**Remuneration:**

A Firefighter receives an annual retainer fee in line with length of service:
