#### **Andrew Reddington**

- I will propose:

11. "that Galway County Council investigate the possibility of placing CCTV at bottle recycling across Co Galway. This will in turn reduce the amount of illegal dumping occurring in our rural towns."

#### **Donagh Killilea**

- I will propose:

12. "that Galway County Council withhold all public funding or payments of council funds/transitional funding to companies, developers or directors of building companies or former developers or directors, who have not complied with conditions of planning where housing estates/developments have not been finished by them or their entities. This funding should remain in trust with Galway County Council until estates are completed and taken in charge by the council. It is not good enough that some developers are able to dispose of assets to Galway County Council, while leaving the same local authority to complete estates on their behalf."

#### **Shelly Herterich Quinn**

- I will propose:

14. "that the executive to write to Minister Charlie Flanagan of the Department of Justice & Equality on the subject of CCTV and Gardaí numbers in Rural Ireland. I request we propose that all CCTV be funded in full by Central Government, maintained by the Divisional Headquarters and that areas which have been repeatedly targeted be given priority for the implementation of surveillance in that area without delay. Furthermore, the newly implemented policing model is ineffective and leaves rural areas detrimentally exposed as evident in Athenry this month and the previous few months. I look forward to your favourable response"
