**ITEM NO.3 TO CONSIDER REPORT TO AN COIMISIÚN PLEANALA UNDER SECTION 37(E)(4) OF THE PLANNING & DEVELOPMENT ACT 2000, AS AMENDED ON THE FOLLOWING -PROPOSED DEVELOPMENT:**  
**CONSTRUCTION OF WIND ENERGY DEVELOPMENT AND ALL ASSOCIATED WORKS, LOCATED WITHIN CLOONDAHAMPER, CLOONASCRAUGH, ELMHILL, COOLOO, LECARROW, DANGAN EIGHTER, LISSAVALLY AND SLIEVEGORM, CO. GALWAY ACP – 323761-25** 4643

*Report dated 10<sup>th</sup> December 2025 was published on the Extranet prior to the meeting.*

Director of Services, Mr. Hanrahan informed the Members that a joint workshop was held the previous week for the Members of the Ballinasloe and Tuam Municipal Districts (MDs), as the proposed development straddles the boundary between both MDs. The Cathaoirleach of each MD made submissions on behalf of their respective MD, to be included with the Planning Report. The decision to grant or to not grant the development lies with An Coimisiún Pleanála and not Galway County Council.

**Cllrs. Reddington, M. Connolly, Cunniffe, Grealish, Hoade and Keaveney raised the following points and queries:**

- The Director was thanked for facilitating the workshops, and the MD Cathaoirligh were commended for their efforts in preparing the submissions.
- These developments have the potential to create divisions within communities.
- Preliminary works on this project commenced before Elected Members or the local community were informed of the proposal.
- Criticism was directed at the Government for delays in updating Windfarm Regulations, as the absence of clear guidelines leaves communities without adequate support.
- Concerns were raised regarding the proposed expansion of the solar farm in Ballymoneen, particularly the need to assess the risks associated with lithium batteries.
- Proposed wind farms are generating significant controversy, while existing turbines in Derrybrien are simultaneously being decommissioned

Cllr. Hoade read the following submission on behalf of the Members of the Tuam MD:

*'As members of the Tuam MD, we would like to make the following observations in relation to the CE Report on the Cooloo Windfarm Proposal ACP-323761-25*

We are of the opinion that the following points must be considered by the planning inspector for [An Coimisiún Pleanála](#).

- *The scale of the development with a proposed 9 Wind turbines is not in keeping with the landscape sensitivity of the area. The scale of proposed development will have an adverse impact on the local built environment.*
- *The proposed development has one turbine and associated works that are within the Tuam Municipal district, we strongly object to any of the development taking place within the Tuam MD as it is within the LARES area, an area not deemed appropriate for such a development, we ask that this part be excluded for consideration for that reason.*
- *The scale and siting of the proposed development will also adversely impact the local road infrastructure which are not to a standard for such heavy transport of equipment and building materials.*
- *The scale of the development will have an impact on consumable water, not in keeping with the protection of major drinking water sources for the local population.*
- *The impact of the development on traditional boglands in the area is unprecedented, we are of the opinion that mitigation against such peatland disturbance is not sufficient and will have a longer lasting environmental impact.*
- *The proposed intensification and concentration of large scale SID's within the Tuam Municipal district is not in keeping with sustainable development and could constitute a over development of the district as a whole. We need to protect the built environment for future development in both tourism and amenities and other rural development. The Tuam Municipal district is mapped under the Galway County Council Development plan 2022-2028 Galway County Transport and Planning Study (GCTPS), therefore such proposed developments need to be considered on that basis.*
- *The area's within the townlands of Cloondahamper, Cloonascragh, Elmhill, Cooloo, Lecarrow, Dangan Eighter, Lissavally and Slievegorm, are areas of strong rural communities, such a development if granted could reduce significantly the ability for new rural housing and a protection of the rural*

*population and its future expansion, especially the parts of the area that fall within the Tuam Municipal District.'*

The Tuam MD Submission for inclusion in the Chief Executive's Report, as detailed above was Proposed by Cllr. Hoade and Seconded by Cllr. McHugh Ryan.

Cllr. Peter Keaveney, Cathaoirleach of the Ballinasloe MD read the following submission on behalf of the Members of the Ballinasloe MD:

*'As members of the Ballinasloe MD, we would like to make the following observations in relation to the CE Report on the Cooloo Windfarm Proposal ACP-323761-25*

*We are of the opinion that the following points must be considered by the planning inspector for An Coimisiún Pleanála.*

- The scale of the development with a proposed 9 Wind turbines is not in keeping with the landscape sensitivity of the area. The scale of proposed development will have an adverse impact on the local built environment.*
- The scale and siting of the proposed development will adversely impact the local road infrastructure which are not to a standard for such heavy transport of equipment and building materials.*
- The scale of the development will have an impact on consumable water, not in keeping with the protection of major drinking water sources for the local population.*
- The impact of the development on traditional boglands in the area is unprecedented, we are of the opinion that mitigation against such peatland disturbance is not sufficient and will have a longer lasting environmental impact.*
- We need to protect the built environment for future development in both tourism and amenities and other rural development including one off houses. The Ballinasloe Municipal district is mapped under the Galway County Council Development plan 2022-2028 Galway County Transport and Planning Study (GCTPS), therefore such proposed developments need to be considered on that basis.*
- The area's within the townlands of Cloondahamper, Cloonascragh, Elmhill, Cooloo, Lecarrow, Dangan Eighter, Lissavally and Slievegorm, are areas of*

*strong rural communities, such a development if granted could reduce significantly the ability for new rural housing and a protection of the rural population and its future expansion, especially the parts of the area that fall within the Ballinasloe Municipal District.*

- *Three of the proposed turbines - numbers 6,7 and 8 are in locations that are considered "generally to be discouraged" by the Galway County Council Wind Potential report, for such developments.'*

The Ballinasloe MD Submission for inclusion in the Chief Executive's Report, as above was Proposed by Cllr. Keaveney and Seconded by Cllr. A. Harney.

The Cathaoirleach said that the proposed expansion of the Ballymoneen solar farm is currently progressing through the planning process. He also confirmed that the submissions made on behalf of the Tuam and Ballinasloe MDs will be included in the appendices of the Chief Executive's report that will be submitted to An Coimisiún Pleanála.

*Audited Annual Financial Statement and Local Government Audit Service Statutory Audit Report were published on the Extranet prior to the meeting.*

Director of Finance, Ms. O'Connor presented the Audited Annual Financial Statement for Galway County Council, for year ended 31.12.2024. She explained that the unaudited Annual Financial Statement was presented to and adopted by the Members at the April 2025 plenary meeting and that no changes have been made to the Statement since then. The Statement has been prepared in accordance with the Accounting Code of Practice and Accounting Regulations for Local Authorities in Ireland and the directions for the Minister for the Housing, Local Government and Heritage. She highlighted the main points to note in the report, including that 2024 saw an increase in expenditure year on year of over €13m or 8%. There was a surplus of €1,553 for the year ended 31 December 2024. The overall gross expenditure for 2024 was €181m. At 31<sup>st</sup> December 2024 there was a General Reserve of €47,000.

**ITEM NO. 8 TO CONSIDER THE DRAFT CUSTOMER SERVICES ACTION PLAN 2025-2029**

*Report was published on the Extranet prior to the meeting.*



Mr. Owens, Director of Services gave an extensive overview to the Members on the Draft Customer Services Action Plan 2025-2029. Outlining the core values, ambitions and vision of the plan, the standards that are to be expected in relation to Customer Service and the complaints and appeals process.

It has been considered and recommended by the Strategic Policy Committee (SPC) and Corporate Policy Group (CPG).

**Cllrs. McHugh Farag, Donohue, Kinane, Hoade, Cunniffe, Regan and Maher raised the following points and queries:**

- Whilst digital transformation is crucial it is vitally important that there is no erosion of the personal touch and that the Council maintains its ability to be able to talk to our customers and the public directly.
- The requirement for under-16s to be supervised in Council facilities was queried, particularly as it could result in their exclusion from library services.
- If the County Librarian's views on the age limit had been sought.
- Clarification was sought on the rationale for introducing the age limit and whether an adult could provide a disclaimer.
- It was asked if other Local Authorities have implemented the age restriction.
- Will the age limit also be implemented in the public swimming pools and recreation parks.
- It was proposed to amend the age limit from under 16 to under 12.

**Members Queries were responded to as follows by Mr. Owens:**

- The age restriction was included on the request of the library service, based on a risk assessment relating to the requirements associated with child safeguarding.
- The restrictions would only apply to indoor civic buildings.

**Cllrs. Donohue, Mannion, D. Killilea, McHugh Farag, Geraghty, Kinane, McHugh Ryan and Welby raised the following points and queries:**

- The age limit was not highlighted at the Loughrea MD meeting.
- Is there currently an age limit in force at the moment.
- The matter should be deferred until the January plenary meeting.
- The feedback of the library staff should be sought.
- Staff need to be protected.
- It is unfair to exclude all children aged between 12-16.
- Will this affect the mobile library service.
- The presentation by the Drugs & Alcohol Task Force, delivered at the November plenary meeting, emphasized the need for spaces for young people; this proposal runs counter to that objective.
- Is the decision to implement an age limit a Reserved Function.

**Members Queries were responded to as follows by Mr. Owens:**

- The request for the age limit was received from the library service with regard to requirements relating to child safeguarding.
- If the item is deferred until the January plenary, it would provide an opportunity for further review by the Library Service.

**CLIs. Donohue, M. Connolly, Keane, Reddington, Kelly, O Curraoin, Canning and McHugh Farag, raised the following points and queries:**

- Were the Library Association of Ireland were consulted on the matter.
- A solution to fixing the issues needs to be found, not a blanket ban.
- If there are specific problems, they should be dealt with as they arise.
- The item should be deferred until the January plenary, when more information is available.

**Members Queries were responded to as follows by Mr. Owens:**

- Confirmed that the approval of the Draft Customer Services Action Plan 2025-2029, will be a matter for the Members.

- The library service will be asked to confirm who was consulted regarding the age restriction.

On the **PROPOSAL** of Cllr. Mannion **SECONDED** by D. Killilea it was agreed by the Members that a decision on the Draft Customer Services Action Plan 2025-2029 be deferred and included on the January 2026 plenary agenda for further consideration.

**Cllrs. Maher and Regan raised the following points and queries:**

- Clarity was sought on the Council's role in the provision of a Swimming Pool in Loughrea.

**Members Queries were responded to as follows by Mr. Owens:**

- The proposed Loughrea Swimming Pool is a Community Initiative. It is not led by Galway County Council, but the Council will support a viable proposal.
- The first step in the process is to find a suitable site.
- There is no window of funding available at the moment.

The Chief Executive confirmed that the Council will work with the Loughrea Community on this Community Infrastructural Initiative. He added that there is a significant amount of work to be done before the project reaches the funding application stage.

Requests for Civic Receptions at Municipal District level can either be submitted in writing to the Cathaoirleach or Meetings Administrator or referred to the relevant MD by the CPG.

The Chief Executive stated that it was imperative that a reserve corridor exists in the County Development Plan/LAP.

**ITEM 14. NOTICE OF MOTION**

**Cllr. Regan submitted the following Notice of Motion prior to the meeting:**

*'Galway County Council write to ComReg to highlight a serious and persistent issue with mobile phone coverage across Ireland. I travel extensively throughout the country for work, and over the past year, the reliability of mobile service has noticeably deteriorated across multiple regions and on multiple networks. In areas that previously had dependable 3G/4G coverage, I am now regularly experiencing: Complete loss of signal; Calls dropping mid-conversation; Data speeds falling to unusable levels; Long periods of "No Service" even in populated areas. This decline is having a direct impact on people to work efficiently and to stay connected while travelling. I would like to understand whether this reduction in coverage is the result of: **Reduced output or maintenance of existing masts and repeaters, Reallocation of resources towards 5G rollout, or Other technical or operational changes** within the network. While investment in future technologies is important, it should not come at the expense of basic, reliable nationwide coverage—something customers already pay for and reasonably expect. I would appreciate clarification on what is causing these issues, as well as any planned measures to restore and improve coverage across the country. Given how widespread the problem has become, I believe a clear explanation and corrective action are urgently needed'.*

After a discussion where it was pointed out that ComReg had previously refused an invitation to address the Council, it was decided that the motion should also be sent to the Minister for Communications.

On the **PROPOSAL** of Cllr. Regan **SECONDED** by Cllr. Lee the above motion was **AGREED**.

**ITEM NO. 15 CATHAOIRLEACH'S BUSINESS**

**4655**

The following motion was **PROPOSED** by Cllr. Kinane **SECONDED** by Cllr. Keane:

*'I propose that Galway County Council's Active Travel Project Team immediately consult directly with residents of Beech Grove and Beech Park Estate Oranmore, and fully address residents' concerns regarding the Safe Routes to School works that have recently commenced in these areas.*

*These works have had adverse effects on entrance to residents' homes and were initiated without direct consultation with affected residents. Furthermore, no briefing was provided to the elected members of the Gort–Kinvara Municipal District, who represent this area, in contrast to the briefings that were provided to Athenry–Oranmore Municipal District councillors.*

*I also seek a commitment that, where any similar Active Travel works are proposed within the Gort–Kinvara Municipal District, the relevant area engineers and elected members will be consulted in advance.'*

Cllr. Kinane emphasised the urgency of her motion, noting that the Active Travel works are restricting residents' ability to leave their homes and have made the area increasingly hazardous. She expressed concern over the lack of communication with affected residents and Members of the Gort-Kinvara MD, where the works are taking place. She requested that residents be consulted by the following day

Following discussion, the Cathaoirleach confirmed that the Members were agreeable to the taking of the Motion.

Director of Services, Mr. Finn assured Cllrs. Kinane and Keane that the Active Travel team will follow up with the residents. He added that the works were not advertised in the newspaper but via Consult.ie

**Cllrs. Kinane, Keane and Thomas raised the following points and queries:**

- Information on works of this nature should be distributed via a letter drop or local public signage.
- Frustration was expressed that the area is split between 2 Municipal Districts.
- Active Travel works on the Ballybane Road were referenced.

**Members Queries were responded to as follows by Mr. Finn:**

- The Active Travel works were undertaken to address safety issues at the school and the works comply with the approved design.
- It was acknowledged that Oranmore is situated on the boundary of two Municipal Districts.
- He will discuss the issue with Cllr. Kinane following the meeting.

On the **PROPOSAL** of Cllr. Kinane **SECONDED** by Cllr. Keane the above motion was **AGREED**.

The Cathaoirleach invited the Members to watch a short film 'Mise Éire', made in collaboration with Gaelscoil Riada. The Irish Officer, Mr. O'Donnchadha, introduced the film and thanked the producer Mr. Colm Ó Foghlú Galway County Council partnered with Gaelscoil Riada to produce Mise Éire for Scoil an Phiarsaigh 2025. Premiered on Day 1 and presented to the Cathaoirleach, the film captures youth perspectives on climate action and sustainability, creating a lasting cultural archive. By investing in local talent and fostering collaboration, the Council has strengthened Irish language networks and showcased its commitment to cultural renewal. This reimagined two-day programme blends heritage with innovation, aligning with national policy and promoting inclusivity, creativity, and community engagement.

**Cllrs. McHugh Farag, D. Killilea, Cunniffe, Grealish, Geraghty, Keaveney, M. Connolly, McClearn, Feeney, O Curraoin raised the following points and queries:**

- Acknowledged the powerful message of the video which echoed her sentiments on the item earlier in the meeting, regarding the admittance of under 16 year olds to public libraries.
- The Members were encouraged to inform constituents of the importance and benefits of applying for the European Health Insurance Card from the HSE.
- Disappointment that the Ladies All-Ireland Senior Club final was not shown on television.
- Disappointment that GAA matches are scheduled to conflict with ladies Football and camogie final matches.
- That Kilkerrin Clonberne be invited into County Hall for a civic reception to be held in their honour.
- It was asked that the proposed expansion to the Ballymoneen solar farm be halted due to concerns of public safety. Decisions should not be made until guidelines are received from the Government.

The Cathaoirleach asked that the civic reception request be submitted to CPG for consideration.

The Chief Executive assured the Members that the Council is winter ready. The proposed solar energy farm in Ballymonneen is at the pre-planning stage. All renewable energy applications of this nature are dealt with in a comprehensive, impartial and balanced manner. Kilkerrin Clonberne and Athenry teams are examples for us all. He thanked the Elected Members, Executive and staff for the huge works efforts and progress made in 2025 and wished everyone a Happy Christmas.

The Cathaoirleach stated that the January plenary meeting will commence at 1pm, due to a civic reception that will follow the meeting in honour of the Galway Senior All Ireland Camogie Champions 2025, Galway U16 All Ireland Camogie Champions

2025 and James & Conor Canavan All Ireland Fleadh Champions 2025. He thanked everyone for their assistance during the first 6 months of his term as Cathaoirleach and reminded everyone that Christmas lunch is to follow the meeting.
