- For buildings that are not a Protected Structure or within an Architectural Conservation Area the applicant should outline why it merits consideration under the scheme.
- Copies of quotations/estimates for proposed works or report
- Specifications for proposed works, detailing the materials and methodology to be used
- For conservation reports an outline of the structure/content of the proposed report is to be submitted.
- Details of Conservation Professionals accreditation or a statement of their relevant conservation qualifications and demonstrated conservation experience is to be provided.
- Photos showing current condition of element to be repaired
- Please note that as all bat species are protected by law a bat survey may be necessary where works are proposed in locations where they may roost or breed such as historic roof spaces, stone walls or outbuildings
